Edgemont & Upper Capilano Community Association (EUCCA) General Meeting Tuesday June 21st 2011; 7:00pm Potlatch Room Chair Grigor Cameron DRAFT Minutes

1. Welcome and Introduction of Guest Speakers.

Chairman noted the attendance at the Federal Election All Candidates Meeting was around 400. Feedback from participants and attendees was very positive, particularly with respect to format.

2. Presentation on Current Police Issues by Inspector Chris Kennedy (future Superintendent) and Inspector Janice Tompkins - Operations Support Officer.

The current police activities were very clearly described. There are two different levels of concern, the offences which do not have a serious community impact, and the very serious crime which leads to violence and social disruption. Policing is a very expensive service, the personal require years of training and sophisticated supporting equipment and services. The allocation of funds to deal with the different problems is a difficult problem.

The North Shore has become the focus of Lower Mainland drug related crime. There are several reasons for this, including the long water front which provides easy clandestine access. In particular the Lower Lonsdale corridor is particularly vulnerable because of the high density of development.

The local RCMP contingent has conducted special intense operations in the Lower Lonsdale area over the past two years. A special grant of \$175,000 was made available by the City and the preliminary results show some improvement in the crime statistics.

The concentration on serious crime has resulted in a reduction of the community policing and the elimination of the Community police Centres.

Inspector Chris Kennedy made the point that the total crime rate on the North Shore is actually diminishing quite steeply. The following summarises the achievements of the past year:

Organised Crime

Four large scale projects netted 32 Criminal Code trafficking charges.

Traffic

82 Impaired Driving charges forwarded to Crown Council. 155 - 24 hour suspensions.
65 vehicles impounded under the IPR Legislation. 5 local traffic projects targeting distracted drivers. 2403 V.Ts/Warnings issued for various infractions.

Youth

over 400 Positive Tickets issued.10 Youths selected for the RCMP Youth Academy.99 School presentations on topics such as drugs, alcohol, bullying, DARE and stranger awareness.

Crime Reduction

53 Prolific Offenders with Court imposed conditions checked resulting in 16 criminal charges.

Lower Lonsdale Project

over 890 person hours dedicated. 340 street checks conducted. 175 files created. 422 VT"s issued. 150 By-Law Tickets issued. 134 VT's/Warnings issued for traffic offences. 99 Liquor Offence Tickets issued. Drug possession files up 127%. 32% decline in theft from auto's.

3. Edgemont Village Banners

Brian Albinson summarized the history of the banner replacement project and Grig Cameron reported on the final selection of the design. The presentation document is attached.

The meeting passed without dissent a resolution requesting that DNV Council complete the banner replacement with the selected design, together with re painting (and straightening where needed) the poles as soon as possible.

4. Presentation on Business in the Village by Laura Clarke

There will be a program of Friday evening concerts (Jul 8-Aug 26) but the Harvest Festival is cancelled because of funding limitations. Show & Shine (cars) takes place Sun July 17th The business community supports the banner replacement project, and requests that the new banner fixings be the same as the old ones so that the Christmas candy wrappers can be installed. The lights and the wrappers cost the Business Association around \$30,000.

The Business Community, renamed from the Edgemont Merchants Association, to the Edgemont Business Association, welcomes close cooperation with the Edgemont & Upper Capilano Community Association.

There has been some shoplifting taking place in the village. If customers observe this taking place they should discretely notify staff.

- Garden Works "property" (not the business) is up for sale no bites
- Village Flavours has been replaced with take-out pizza
- Currents closing in July
- Queens Stationary new owners are renovating
- Sun tanning place replaced the former Community Policing Station

5. Council issues by Corrie Kost

a. Proposed tree regulation bylaw



Proposed Tree Regulations Bylaw

- •Trees with DBH > 0.75m (>30" diameter at breast height)
- •Trees on a slope > 30%
- •Bird Occupied (April 1- Aug 1) Tree(s)
- •Western Yew Tree with DBH > 0.25m
- •Tree(s) protected by Covenant

•Cutting such a large healthy tree:

- Replace 3 for 1 or
- Pay \$500 Environmental fee to DNV or
- \$0 if declared a hazard by arborist (\$200-\$500)

b. New proposed garbage bylaw



Animal Proof Latches on Containers (~ \$75 each installed)

According to DNV 2010 Annual Report, District level actions in terms of the Solid Waste Management Plan are awaiting Metro Vancouver decisions on the Plan and on organics collection. In meantime, DNV will continue to enforce current limits, pursue internal efficiencies, and plan for organics collection anticipated for late 2011/2012. Conversation with council members indicate DNV is not able to process organics on North Shore and shipping to Burnaby is not desirable.

c. New sprinkling regulations

- Apply Yearly June 1 to September 30
- Residential addresses may sprinkle lawns:

Even-numbered addresses: 4am - 9am DAYS 2-4-7 : Mon, Wed, Sat

Odd-numbered addresses: 4am – 9am DAYS 1-3-5 : Sun, Tues, Thur

No one can water on Fridays (for fish)

Watering regulations do not apply to flower, shrub, or vegetable gardens, car washing or washing down surfaces for painting/sealing, etc.

"Beauty lies in the eye of the beholder".


This has been confirmed in spades in our efforts to achieve consensus over the banner design over the past 2 ½ years. A brief review of the effort made follows;





Multigraphics; July 2010; produced these using the four seasons concept BUT NO LIONS!








Multigraphics ; July 2010 ; included Lions which looked a bit jaundiced and the flora a bit thin











New Development November 2010
