'Hopes and Fears': How do our residents feel about the future?

- A sustainable population all age groups all stripes
- Keep open spaces
- Carbon neutral
- Carbon reduction
- For my kids to one day be able to afford to live here
- Maintain natural setting
- Affordable housing for my children
- More funding of health care (non-profits) by municipalities
- That we no longer need fossil fuel powered cars
- Pedestrian and bicycle friendly. <u>Truly</u> friendly

- A completely sustainable community. Ability to live and work in my neighbourhood

What needs to change?

- For density yes it is inevitable but no high towers en masse
- It RAINS here. Why don't we have more places <u>with shelter</u> (like Delany's in Edgemont) where we can congregate. It is often not cold, but very often wet. We can't have a vibrant cafe culture in the rain
- Emphasis on other modes of transportation other than cars

- An improved governance structure that allows us to respond quicker to meet the unknown future
- Seniors' housing
- Good basic cost effective amenities water sewer, etc.
- Too much development without community facilities close by. Don't want to have to get in my car to get a loaf of bread
- More money and manpower to protect natural ecosystems and restore and reclaim those that require \$ to get back to their original splendour
- Need to be more sensitive to our diverse cultures
- I am concerned for the future of our watershed areas. No balance with recreation and conservation
- My adult children if they choose could come back to the North Shore
- Health care for seniors will we have enough?
- Stronger sense of collective interests and threats
- Less wasteful practise in terms of water use and garbage production
- Emphasis on single family dwellings more retail/commercial and residential mix
- Engage youth in civic affairs, especially planning for their future
- Yearly 4-5% tax increases are unsustainable in the long run. This, more than high house prices, will prevent young families from living in the DNV
- Appropriate housing for all more diversity in housing
- Need more neighbourhood parks with play equipment
- Ban single use grocery bags
- Well designed low rises and duplexes in areas of single family homes
- Need more creative, 'dense' housing for all \$\$ levels
- If population is declining, stop building giant houses for 2/3 people!
- Please do not develop any higher up the mountain sides!
- Adaptability from youth to seniors' with mobility issues accessibility
- 'Will' to change follow through and commit to sustainable actions that support community
- What must change? The broken housing model. Our ability to sustain a job base. The frightening demographics of community stagnation
- We can't sustain more population growth. We're already beyond our real carrying capacity.
- Actively engage youth in community planning
- Avoid too many 'rules'
- Engage youth in community arts, plans, sports on a neighbourhood basis
- Integration of seniors into the community less segregation/ghettoizing

- Better transit service more frequency on many routes. Use of smaller buses where possible
- Housing for addicted/mental health clients funded in part by DNV
- Stop proliferation of big box houses that destroy the character of our neighbourhood and are the antithesis of sustainable building practices
- Agreed higher density doesn't mean towers. Density can mean tighter community bonds, safer spaces, less transit;, cheaper services and amenities, more people connections and fun!
- Getting more shared use of community buildings like schools and churches
- Density needn't be towers! Talk to Michael Geller
- We have to let go of the unsustainable dream of large lots, single detached homes, with 2 car garages higher density
- Move forward with OCP asap!
- Need more affordable housing
- Relevant but realistic goals (time and resources)
- Fear of exclusion too pricey monolithic community
- OCP amendment process is too complicated
- I'll have to move my old age because no affordable housing
- Mixed use single family multifamily high rises seniors singles, etc.
- More trails and bike routes
- Gradual increases in density preferred to mitigate concerns by residents (pilot projects?)
- More affordable housing
- Make sure we have clean water high cost of energy
- More wheelchair accessible parks
- Housing on top of stores, village style
- Bike routes better buses
- Respect to wildlife, they're her first. Examine other regions' protection acts
- I need a mansion
- High municipal taxes, overcrowded services with waitlists, lack of affordable daycare and few public schools (some with 'lotteries') are the real obstacles for families
- Control litter and graffiti- community pride, property values and taxes are effected
