## 3.a) EUCCA (Corrie Kost)

#### William Griffin

- Borrowing \$28M, have \$2M from contingency fund
- Dedicated website for WG updates
- Info listed in Outlook; should also be in NS News
- Rec Commission advised there will be two open houses following design submission

#### 129 unit senior complex planned for outside Edgemont Village

- 3 stories; will occupy 6 current single family zoned lots + road
- For profit rental facility; zero affordable units which is alleged as contrary to OCP which supports affordable housing
- Lower densification was planned for Transition sites like these; max 0.8 FSR for Residential level 3 and up to 1.2 FSR for Residential level 4. Proposed is FSR is 1.5
- Divisive issue for the community

#### 3.b) East of Seymour Issue (Eric Andersen)

- Prior to OCP implementation a commitment was made for the Seymour Development Plan which would cap development at 50 units per annum
- Further to various meetings with Council and staff, and various communications, there is conflicting information as to the status of the 50 units/annum
- Council has advised staff no further development encouraged for one year and then revisited
- This issue requires urgent clarification and the policy needs to be clearly stated for the record

- Lower Capilano Implementation Plan is furthest along; could be adopted by summer

#### 7. a) FoNVCA Website Hosting Renewal

 Three year period cost is \$400 = \$40 per CA; Corrie will pay and recoup funds as required following request for funds to DNV

#### 7. b) DCC (Development Cost Charges) Bylaw Review – Parks DCC – Corrie Kost

- DNV Council has approved bylaw (awaitin Ministry approval for adoption.
- In 1998 Parks DCC was \$4090/unit; 2013 Parks DCC will be \$1325/unit; with inflation and increase in land value \$12000 per unit Parks DCC was reasonably justified
- Imbalance of Parks DCC means a growth 'subsidy' of \$500M over 20 years by existing residents

A lively discussion followed; this is a worrisome bylaw and a major public policy change that could dramatically affect the DNV for generations. Parks are a high priority for all communities. This is a perplexing directive.

**Action:** Individual CAs to contact M & C with concerns

#### 7. c) Public Assembly Land Review Strategy (Sharlene Hertz)

- Documents just released with strategy and recommendations; requires further investigation
- At first examination, no firm statement by DNV Council to unreservedly preserve all PA lands in perpetuity
- Town/Village Centres slated for priority treatment 'priority locations for new PA uses'
- Principles/criteria have been developed to evaluate proposed changes to PA lands
- CACs are recommended where rezoning or redevelopment of PA land is considered Discussion followed. There is a stakeholder meeting in April at District Hall; more details to come.
