2. ADOPTION OF Oct 16TH MINUTES

No amendments. Adopted unan.

3. OLD BUSINESS

Letter of thanks for district staff sign presentation was sent to Council.

3.1 Council to discuss Sign Bylaw Tuesday November 25th District wants each area Deep Cove, Lynn Valley etc. to meet to discuss how the new Bylaw would work (or not) in each area. Some concerns were expressed on potential non-conforming signs being put in place after the main sign Bylaw is approved but before local character sign areas are approved.

Motion - to request Council to defer adoption of sign Bylaw until such time as each sign character areas **specific** regulations are incorporated into the draft. Brian/Hugh carried unanimously.

4. CORRESPONDENCE ISSUES

4.1 Business arising from regular emails:

Issue that legalizing suites in residential zones should generate DCC's for infrastructure costs was discussed.

4.2 Non-Posted letters. None this period. However, Brian & Corrie had made a decision to put a letter on the website only on the condition that the persons name must be provided (ie. anonymous emails will not be posted). The members concurred with this decision and it will be part of normal policy.

5. NEW BUSINESS

5.1 Debris Flow Studies:

Some discussion toke place on this issue as a result of the special Oct 27^{th} council policy decision

(http://www.dnv.org/upload/documents/Council_Agend as_Minutes/cm031027.htm to consult associations and

other stakeholders by sending them summary report and holding a meeting on this issue. At issue is who will pay for the approx \$27million cost to fully mitigate the potential risk to some 300 homes. Options range from sharing the costs by all taxpayers via a utility fee, to the full costs being born by the stakeholders (eg. those who exacerbate the risks).

5.3 Liquor Sales – Council was to institute a number of zoning bylaw amendments to which FONVCA was to input by Nov 19th 2003. There were no problems foreseen with the proposed changes.

5.4 GVRD's meeting on Lower Mainland Water Supply

after a discussion of the issues a letter is to be sent to GVRD cc. Council expressing concern on **inappropriateness of charging for attendance at GVRD public meetings** (held in public place by a public employee) on important infrastructure issues (in this case the future of Lower Mainland's water supply on Nov 12th held at the Learning Lodge, LSCR). Moved by Brian/Cathy and carried unanimously.

Mayor & Council:

At the November 20th meeting of the Federation of NV Community Associations, a discussion took place on the Provincial Government's proposed Bill 75 - Significant Projects Streamlining Act. The concern over this Bill is that any project deemed by Cabinet (or any Minister named by Cabinet) to be "provincially significant" may result in the overriding of all municipal approval processes. Currently, the Provincial Government can override a municipality only on matters of land use and the regulation of property tax rates. Bill 75 goes much further. According to a UBCM information flyer released November 7th, it was noted that the Bill:

- "Applies to everything local government can do -- from a service (a proponent could say it was in the public interest to allow competition with exclusive municipal service provision) to a regulation.
- No notice to local government is required before a project is designated by Cabinet.
- Applies to everything a local government can approve -- financial, land use, building permits. Examples of what could be overridden
 - taxation
 - zoning
 - development cost charges
 - building bylaws
 - business regulation
 - noise or other nuisance regulation
 - other land use controls
 - signage
 - fees and charges
 - access requirements
 - subdivision requirements
- It may also indirectly affect local governments if they are considered a 'constraint' because they are part of a referral process -- referrals may be argued to be a 'constraint', and if accepted, the local government would have no notice of a project."

In light of the above, FONVCA urges Council to actively support the position of the UBCM Executive in calling on the Provincial Government to remove local government from Bill 75.

At the November 20th meeting of the *Federation of NV Community Associations* a discussion took place on the process for approving the District's sign bylaw. Of specific concern is the implications of adopting the new bylaw that designates sign character areas of Deep Cove, Edgemont Village, Lynn Valley and Marine Dr., but which leaves open the inclusion of more thorough regulations for each of these areas some time in the future. FONVCA believes that such a process could potentially result in inappropriate signage being installed prior to the creation of more area-specific sign regulations being implemented. It was therefore moved and carried unanimously

"That FONVCA request Council defer the adoption of the new sign bylaw until such time as each sign character area's specific regulations are incorporated into the draft."

It should be stressed that notwithstanding the above motion, FONVCA does not wish to see the sign bylaw deferred for a lengthy period of time. Indeed, FONVCA believes that a deferral is necessary to initiate the prompt inclusion of more specific regulations for each character area. If the draft bylaw is adopted as is, any amendment afterward to address the character areas will require a full Public Hearing process and therefore would take considerable time to complete. Far better that the character areas be thoroughly addressed beforehand, and the specific area regulations incorporated before the new sign bylaw is adopted.
