Brian introduced James Ridge, Chief Administrative Officer of the District of North Vancouver. James Ridge then gave a brief outline of his past work experience. This was followed by a more detailed outline of his vision for the District. Areas discussed were:

-arts co-ordination

- -BC ambulance service
- -internal auditing reporting relationships
- -legal services
- -policing
- -building assessments
- -council procedures
- -contract renewals

A concern was also expressed on the adequacy of FONVCA's current policy on the screening of posted letters [to be placed on next month's FONVCA agenda]

James Ridge (with encouragement) stayed for duration of meeting.

2. ADOPTION OF Jan 15TH MINUTES

At suggestion of Dan the wording "usual purchasing system" in item 3.1 was changed to "a typical purchase order system". Adoption of minutes with above change was moved by Allan, seconded by Dan and carried unanimously.

3. OLD BUSINESS

3.1 Canopy Walk Approval Process

Corrie distributed the hand-out as noted in previous meeting.

3.2 Northlands

Sentencing on the theft of district funds is to take place March 12^{th} at 1:30pm. Cathy to provide any updates.

Doug Allan's response letter

email.pdf was circulated. This was in relation to ensuring harmonization of sign character areas with proposed sign bylaw. Cathy also contacted Doug about her specific concerns with Marine Drive sign character area and Doug informed her that he had done his report to council. This item requires follow-up when it goes to council as staff position does not align with that of FONVCA.

4. CORRESPONDENCE ISSUES

4.1 Business arising from regular emails:

Some 58 emails were posted Dec 15/2003 to Jan 11/2004. Corrie briefly reviewed them. Most issues are included in current agenda.

4.2 Non-Posted letters. None this period.

5. NEW BUSINESS

5.1 Property Tax Assessment:

Corrie reviewed the existing thresholds on losing the home owners and supplementary grant – former lost by any assessments over \$572,000 and the latter also lost by assessments over \$599,500. Whistler's threshold was set to \$2,000,000. A figure of \$800,000 would be in line with assessment increases since 1996 (no change since then) to again cover about 95% of homeowners. He also noted that **Property Transfer Taxes** – 1% of first \$200,000 and 2% above that – with a First-Time buyers exemption of only \$275,000 and complete exemption phase-out at \$300,000 in lower mainland means an upfront payment by buyers of \$8,000 on a \$500,000 home. Lack of adjustments another windfall to province and download to taxpayers. Corrie also reviewed the attractiveness of **deferring property taxes** for those age 60+.

5.2 Ipsos-Reid Translink Survey

Corrie distributed his response to this translink survey <u>http://www.fonvca.org/agendas/jan2004/ipsos-reid-</u> <u>response.pdf</u> it's deficiencies. Allan reported that the Seymour Community Association has passed a motion re: TRANSLINK funding on Jan 14th. Brian to write a letter to council endorsing support for items 2, 3, and 4 of the SCA motion (**attached**). Corrie stated that the parking levy is for anything 'non residential', with concern expressed as to what this then applies to.

5.3 Recreation Vehicle /Boat Bylaw 7387

Corrie reviewed, what he termed a flawed bylaw, and the fear that next year the situation could even worsen – given what was expressed by some members of council debating this issue.

5.4 North Shore Recycling Program

Corrie commented that, in consideration of the limited mandate, the Smythe Ratcliffe report <u>http://www.dnv.org/upload/documents/Council_Reports/002</u>53.pdf was a good report. The program's overall cost effectiveness (taking into account time and materials

downloading to the taxpayer and environmental impacts) was never reviewed.

6. ANY OTHER BUSINESS

6.1 Legal Issues to think about.

The issue of free passes / family subsidies to councillors sitting on boards/commissions was debated. Section 100-106 of Community Charter – distributed – was relevant to this issue. <u>http://www.fonvca.org/agendas/jan2004/CC-COI.pdf</u>

Concern was also expressed about potential conflicts of interest of member of council's ties with real estate dealings.

SCA Motion:

On January 14, 2004 the SCA met and passed the following motion:

The Association is unalterably opposed to Translink¹s funding options as outlined in the 3-10 year transportation plan for the following reasons:

I. The Board of Translink is not elected by residents at large and has no political or moral authority to fund its 3 year plan by accessing the property tax

2. The tax does not discriminate between users and nonusers of the transportation system. There is strong support for a user-pay method of funding the transportation system.

3. Residents, such as those living on the North Shore, will be taxed unfairly for the minimal services received, because of historically high property assessments.

4. Together with groups in opposition to the RAV project across the GVRD, the Association is opposed to the disproportionately higher cost of using Skytrain technology and tunnelling under Cambie Street, versus, the more cost-effective system of at-grade light rapid transit.

This motion was passed unanimously at the SCA meeting. Participants at the meeting included representation from every part of the boundaries of the Association: Windsor Park, Roche Point, Dollarton, Parkgate, Indian River, and Deep Cove.

At the January 16th meeting of the *Federation of North Vancouver Community Associations* (FONVCA) consideration was given to the proposed RAV line and Translink's funding options as outlined in 3-10 year transportation plan.

FONVCA's position is outlined in the following motion that was approved unanimously

- 1. That a Translink property tax does not differentiate between users and non-users of the transportation system. There is strong support for a user-pay method of funding the transportation system.
- 2. Residents living on the North Shore will be taxed unfairly for the minimal services received, because of historically high property assessments.
- 3. Together with groups in opposition to the RAV project across the GVRD, the *Federation of NV Community Associations* is opposed to the disproportionately higher cost of using Skytrain technology and tunneling under Cambie Street, versus the more cost-effective system of at-grade light rapid transit.

The *Federation of NV Community Associations* is an umbrella organization representing 18 residents' associations across the District of North Vancouver. Regular FONVCA meetings are held at the NV District Hall on the third Thursday of every month for the purpose of sharing information and discussing issues of common concern. Your Worship & Members of Council,

I was shocked beyond belief to have staff say that a legal opinion had been rendered that to undedicate a dedicated park **requires** a referendum. After all the many months of effort by myself and the community to inform council and the provincial government that the Community Charter allows for the undedication of a dedicated park without requiring a referendum I am just dumbfounded.

So let me ONCE AGAIN state the obvious arguments:

Section 30 (attachment 1) of the Community Charter says:

(3) A bylaw that removes a reservation or dedication referred to in subsection (2) may only be adopted with the **approval of the electors**.

NOTE subsection (3) says "APPROVAL"

Now what is the definition in the charter for "APPROVAL"?

For that we need to go to section 84-86 (attachment 2): The relevant part defines "approval" as:

(a) assent of the electors in accordance with section 85, Or

(b) approval of the electors by alternative approval process in accordance with section 86.

If you read section 85 you will conclude that "assent" means "referendum"

If you read section 86 you will conclude that "approval" means "counter-petition"

Thus a Council by simple majority vote could undedicated a dedicated park by following an "approval" process which uses the "approval of the electors by alternative approval process" – namely a counter-petition. They are not obliged to obtain "assent".

Had section 30(3) said "assent" instead of "approval" then and only then are we assured of a referendum. With "approval" we can only be assured of a "counter-petition" opportunity.

I rest my case.

ATTACHMENT 1

Reservation and dedication of municipal property

30 (1) A council may, by bylaw, reserve or dedicate for a particular municipal or other public purpose real property owned by the municipality.

(2) As a restriction, a bylaw under subsection (1) that reserves or dedicates property

(a) as a park or public square, or

(b) for purposes related to heritage or heritage conservation, may only be adopted by an affirmative vote of at least 2/3 of all the members of council.

(3) A bylaw that removes a reservation or dedication referred to in subsection (2) may only be adopted with the approval of the electors.

(4) A bylaw that removes a reservation or dedication under subsection (1), other than one referred to in subsection (2), may only be adopted after the council

(a) gives notice of its intention in accordance with section 94 [public notice], and

(b) provides an opportunity for persons who consider that they are affected by the bylaw to make representations to council.

(5) Bylaws adopted or works undertaken by a council that directly affect property reserved or dedicated under this section must be consistent with

the purpose for which the property is reserved or dedicated.

(6) A reservation or dedication under this section does not commit or authorize a council to proceed with implementation of the purpose for which the property is reserved or dedicated.

ATTACHMENT 2

Approval of the electors

84 If approval of the electors is required by or under this Act or the Local Government Act in relation to a proposed bylaw, agreement or other matter, that approval may be obtained either by

(a) assent of the electors in accordance with section 85, or

(b) approval of the electors by alternative approval process in accordance with section 86.

Assent of the electors

85 (1) If assent of the electors is required or authorized by or under this Act or the Local Government Act in relation to a proposed bylaw, agreement or other matter, that assent is obtained only if a majority of the votes counted as valid are in favour of the bylaw or question.

(2) Part 4 [Other Voting] of the Local Government Act applies to obtaining the assent of the electors.

Alternative approval process

86 (1) Approval of the electors by alternative approval process under this section is obtained if

(a) notice of the approval process is published in accordance with subsection (2),

(b) through elector response forms established under subsection (3), electors are provided with an opportunity to indicate that council may not proceed with the bylaw, agreement or other matter unless it is approved by assent of the electors, and

(c) at the end of the time for receiving elector responses, as established under subsection (3), the number of elector responses received is less than

10% of the number of electors of the area to which the approval process applies.

(2) Notice of an alternative approval process must be published in accordance with section 94 [public notice] and must include the following:

- (a) a general description of the proposed bylaw, agreement or other matter to which the approval process relates;
- (b) a description of the area to which the approval process applies;
- (c) the deadline for elector responses in relation to the approval process;

(d) a statement that the council may proceed with the matter unless, by the deadline, at least 10% of the electors of the area indicate that the council

must obtain the assent of the electors before proceeding;

- (e) a statement that
- (i) elector responses must be given in the form established by the council,
- (ii) elector response forms are available at the municipal hall, and
- (iii) the only persons entitled to sign the forms are the electors of the area to which the approval process applies;

(f) the number of elector responses required to prevent the council from proceeding without the assent of the electors, determined in accordance with subsection (3):

- (g) other information required by regulation to be included.
- (3) For each alternative approval process, the council must

(a) establish the deadline for receiving elector responses, which must be at least 30 days after the second publication of the notice under subsection(2),

(b) establish elector response forms, which

(i) may be designed to allow for only a single elector response on each form or for multiple elector responses, and

(ii) must be available to the public at the municipal hall from the time of first publication until the deadline, and

(c) make a fair determination of the total number of electors of the area to which the approval process applies.

(4) The council must make available to the public, on request, a report respecting the basis on which the determination under subsection (3) (c) was made.

(5) For the purposes of this section, the electors of the area to which an alternative approval process applies are the persons who would meet the qualifications referred to in section 161 (1) (a) [who may vote at other voting] of the Local Government Act if assent of the electors were sought in respect of the matter.

(6) Elector responses may be made on an elector response form obtained under subsection (3) or on an accurate copy of the form.

(7) For an elector's response to be considered for the purposes of this section, the elector must

(a) sign an elector response form that includes

(i) the person's full name and residential address, and

(ii) if applicable, the address of the property in relation to which the person is entitled to register as a non-resident property elector, and

(b) submit the elector response form to the corporate officer before the deadline established for the alternative approval process.

(8) After the deadline for an alternative approval process has passed, the corporate officer must determine and certify, on the basis of the elector

response forms received before that deadline, whether elector approval in accordance with this section has been obtained.

(9) A determination under subsection (8) is final and conclusive.

(10) A person must not sign more than one elector response form in relation to the same alternative approval process, and a person who is not an

elector for the area of the approval process must not sign an elector response form.

3. The Chief Administrative Officer is authorized to approve expenditures specified in the Financial Plan.
