"THAT the minutes of Nov 18 be approved as amended."

3. OLD BUSINESS

3.1 Election accountability at the polls – Brian put question to the District's Chief Election Officer re: the possibility of dishonest people casting multiple ballots during a municipal election. Agnes responded that in January she will be meeting with other Chief Election Officers throughout the province and promised to raise the subject and will examine what other municipalities do beyond the so-called 'honour system.' Currently the District conducts just a random check of the election books. Discussed possible methods to ensure the integrity of the election process.

3.2 Tax Statistics – residential taxes in DNV rank just below the highest (West Van) and much higher than other municipalities.

4. CORRESPONDENCE ISSUES

4.1 Business arising from 54 regular emails -

Dan read a Dec 2nd letter from Councillor Crist to Liz James (copied to FONVCA) re: the Lynn Valley Library & Town Centre. Dan suggested that Crist is misusing the FONVCA web site to post e-mail that is contrary to FONVCA's mandate. Brian apologized, confirming that the e-mail in question was posted in error and that it should have been held back for a decision on whether or not to post the item. A discussion ensued re: the volume of correspondence from Ernie, FONVCA's policy on receiving correspondence. To conclude the issue it was agreed that the letter in question would be removed from the web site. It was then MOVED by Corrie, SECONDED by Cathy and CARRIED UNANIMOUSLY

"THAT a letter be sent to Councillor Crist stating that FONVCA will protect the reputation of community associations and their volunteer members by not posting on our web site any correspondence that impugns their reputations." – ACTION ITEM

It was further agreed that, upon request two additional separate e-mails would also not be posted. These were both letters that were copied to FONVCA..

5. NEW BUSINESS

5.1 Lynn Valley Library & Town Centre – in light of certain financial constraints, Council will consider, on Dec 20^{th} , new options with respect to the scope of the project.

5.2 Financial Workshop #4

- Concern was expressed that minutes of these meetings have still not been posted on the DNV web site.
- Corrie was admonished at the latest meeting by the Director of Finance and at least one member of Council for attempting to photograph the Powerpoint presentation.
- Question concerning the GST rebate to municipalities. Will it return to the taxpayers as intended?
- James Ridge said that the gasoline tax will not go directly into municipal coffers but will be distributed by the Federal Gov on large infrastructure initiatives with municipal oversight.
- All rec centres require significant capital upgrades estimated at \$31 million.

- Some big capital items will be delayed until '09 when Olympic construction boom is finished and costs are lower.
- Northlands Golf Course building has 'leaky condo syndrome' and requires repair.
- The public will get an opportunity to question the budget on January 25th.

5.3 Boarding of Animals – Corrie reported on Public Hearing. Boarding of animals must have a 50 meter minimum distance from a public building or dwelling unit. Since buildings can move David Knee recommended that the 50 meters be between properties. Concern expressed at allowing boarding of healthy animals at Veterinary establishments. Item will return to Council on January 11th.

5.4 RAV motion by NV District Council – information only.

5.5 Regulation of Liquor Store Hours – when Council addressed this issue Coun. Nixon declared he no longer considered himself to be in a conflict (with respect to the new Edgemont store) but the Charter implies that once a conflict has been declared it cannot later be said to not be a conflict even if circumstances change. Council chose to maintain the status quo on store hours.

6. ANY OTHER BUSINESS

6.1 Public Hearings – see web site agenda links. Under Charter, a Council need not hold a PH to rezone a property, or alter use or density if properties owned by ten owners or less, and provided that the change is consistence with the OCP. This process must include public notification by way of publishing two notices in the newspaper.

6.2 GVWD – Diana raised the issue of the GVWD's unauthorized tree cutting in Lynn Canyon Park. MOVED by Dan SECONDED by Diana and CARRIED UNANIMOUSLY

"THAT FONVCA suggest that Council request from the GVWD appropriate compensation for unauthorized tree removal within the park, the amount of which should be based on a pro-rata formula derived from the amount the GVWD paid for the parkland required for the clearance of trees for the water tunnel shaft, and in addition, to rehabilitate the damaged area." – ACTION ITEM

6.3 Selling Zoning – Cathy addressed the intricate matter of selling zoning – which is illegal according to

the Community Charter. There was a recent court case involving a Hotel proposal at Whistler on this issue. See

6.4 Development Cost Charges – mean that if a property is subdivided, then DCCs are applied to the extra lot; however, this would not apply to the creation of a secondary suite in an existing house. Conversely, DCCs would be applied if a new house included a suite. In addition - the Community Charter now allows DCC's to be levied to a development involving fewer than 4 dwelling units if an appropriate bylaw is adopted by the municipality.

6.5 Water Turbidity – Seymour reservoir out off-line because of mud slides. Capilano is bad too but the readings are not consistent. Why no timely drinking water advisory?

6.6 CRTC – discussion about recent cutbacks to community cable TV. CRTC was said to be very responsive to citizen complaints by calling CRTC in Vancouver at 604-666-2111

6.7 FONVCA Shirtsleeves Meeting With Council – Cathy will check springtime dates with Shana in the Clerks' office. FONVCA members should begin thinking up possible subjects for discussion.

NOTES OF THE CFO'S FINANCIAL WORKSHOP #4 ON INFRASTRUCTURE REQUIREMENTS

Held on Tuesday, November 23rd, 2004 at 5:00pm in the Committee Room by Corrie Kost

Disclaimer: These are my personal notes and may contain errors in both content and interpretation as to what transpired at this workshop. Please check the "official" version posted by the DNV at http://www.dnv.org/upload/documents/council_workshops/fp041123_minutes.htm Some personal notes/comments are also added in italics.

John McPherson, Chief Financial Officer, stated that new Capital projects are driven my community growth and also that without growth we need to decommission those items of low priority. James Ridge, Chief Administrative Officer, stated that low growth adds to pressure of maintenance costs of our libraries, fire-halls, golf course, rec. centers, sports fields. He stated that there are no painless solutions – that sewer/water situation is well in hand but not so for our storm sewers. There was a need to manage public expectations and revisit past investments to see if they are still needed. There is insufficient funds in the Capital budget to cover even maintenance much less consider new projects.

This is hard to accept as the District funded major capital projects by referendum during periods of low growth. As well, during low growth, one need no longer expand facilities but only maintain what one has built – something which is a lot less expensive. In addition, taxes have been increased yearly for the last 7-9 years or so to shift more funds into Capital renewals (maintenance) – and reduce use of Heritage Funds (eg land sales) to fund these Capital renewals so that low growth can sustain these maintenance costs. If we reverted back to growth we would again be adding even more to the tax burden – requiring the current taxpayer to fund them AND their future maintenance. As everyone who purchases a home knows – once the Capital is paid for the burden goes down considerably and one needs only cover maintenance costs.

In the powerpoint presentation by Nicole Deveaux

It was pointed out that the district had a shortfall, averaging \$3m in the 1996-2004 period, to cover the capital renewals. The lowering of the heritage contribution was pointed out. What was not pointed out was that the taxes were systematically increased yearly to compensate for the loss of the Heritage Fund contribution to Capital maintenance. The yearly Heritage Fund contribution to Capital is shown below.



It has been declining yearly till year 2000 when council stopped the phase-out program. It was planned to be phased out completely by 2005 but the Lynn Valley Town Centre funding took 7.5Million in 2003 and some \$4million in 2004.

Some \$52Million has been taken from the Heritage Fund (for "maintenance") from 1996-2004. Over the next 16 years (2005-2020) \$128.8million (in 2004 dollars) has been identified for future capital requirements. **Budgetary items less than \$500K were ignored and if they were included the capital requirements may well be double or even triple that amount.** Only 34% of the \$128.8million has been identified in a funding source - \$85million has still to have a funding source to be determined (much less any excess over the \$128.8million !!). Most of the funding requirements are related to the needs of the Recreational Facilities and there was a suggestion that a "replacement surcharge" user fee be put in place.

Maintenance of our streets and parks continue to have a chronic shortfall of \$3m/yr (split about \$1.5m/yr each).

Corporate services would need \$700K to open up the third floor of the hall. Animal shelter costs (since being taken over from SPCA) are increasing rapidly. William Griffin needs repairs of \$565K for year 2005 with \$700K needed to replace the artificial turn there in 2009. Debris Flow Mitigations are estimated at \$27million. A policy needs to be considered – such as who pays. *I believe that at least 50% should be born by the impacted properties.* It was noted that many of the Powerpoint tables had expenditures in year 2005 – then little in the years to 2020. The museum and archives facility – originally to cost \$1.5million in the 1996 referendum is now to cost \$4.2million. A Federal Cultural Spaces grant of \$425K will reduce the shortfall to \$2,275,000 – which will be treated as a contribution from the Heritage Fund in the absence of an alternate source. (the use of Heritage Funds – ie. Land sales – to fund a *depreciating facility is ill-advised as such a policy is not sustainable*)

Asbestos problems were found in our existing fire-halls - #3 – only 30 years old would cost \$4.6million to replace. It seems the older fire-halls don't have the asbestos problem! Another Quint unit (\$0.85million) would be needed to service native development east of Seymour (hopefully the service agreement would include this factor).

Various options were outlined for meeting the space/seismic needs of the Capilano Library. A \$2million item for this is shown in the 2006 budget. It was noted that "option 3" – a new building at a "new site" would cost \$7.9million but it was also noted that there is "considerable community support to retain the current site location".

The Recreation Commission master plan is being drafted and may change the overall picture – it now stands at \$45million but a lot was not shown.

All the above supposedly represents "upper limits" and is in line with studies made in 2002 And consistent with a \$8million/year requirement to maintain our infrastructure.

Councillor Nixon inquired about new funding opportunities provided by the Community Charter, seemed to support user fees to pay for rec. facilities replacement and suggested avoidance of any new facilities from 2006-2010.

Councillor Muri and Mayor Harris suggested Delbrook facilities be closed and combined with Griffin. Harris suggested housing for the Delbrook site.

Councillor Crist suggested that more development is not the solution and that DNV stop subsidizing CNV by \$6million/yr via rec. commission. He also questioned where \$600K, for the Alpine trails was coming from – apparently from the already chronically under-funded regular parks/trails maintenance budget.

Councillor Nixon suggested District go further into debt and borrow more money. He also wants to get Federal funding for major projects using gas tax.

It is interesting to observe that in 1996 there was a referendum to fund \$26million in capital projects over a 10 year period. The current discussion is about getting \$80-160million over 16 years BUT POSSIBLY WITH NO REFERENDUM!

<u>Mandate</u>: "The Federation is a forum for the common concerns of member associations and its purpose is to strengthen these organizations through the sharing of information and experience."

Dear Councillor Crist:

As part of FONVCA's regular monthly agenda there is an item concerning "non-posted correspondence" whereupon the membership reviews incoming e-mails that have been 'flagged' for discussion as to whether or not to post on our web site.

On the correspondence page it states quite clearly that, "The FONVCA web site is intended to promote the free exchange of information and opinions. Content of messages sent for posting should enhance the debate of district issues."

The policy states further that, "all correspondence will be posted, unless the author explicitly requests that it not be posted, or in the opinion of the secretary of FONVCA that it is inappropriate to do so. In the latter case this correspondence will be distributed at the next regular FONVCA meeting for a final decision. Note that if a named third party (which would normally also have received a copy of the email) requests the email not be posted then FONVCA would consider that request at its next meeting (and in the meantime not post or unpost it as appropriate)."

On December 2nd you copied to FONVCA (and others) an e-mail concerning the Lynn Valley town Centre project. In this particular case, a named third party objected to the e-mail and as FONVCA's secretary I agreed the letter in question should be reviewed at our December 16th meeting.

When the letter was read-out and discussed, FONVCA members unanimously agreed that some of the language used was inappropriate and offensive. Moreover, it was concluded that the e-mail did not promote the free exchange of information and opinion, but rather, was seen as an attack upon a member community association and certain named volunteers. In light of this, it was further agreed that the letter would <u>not</u> be posted.

FONVCA felt it was important to write to you and explain this decision and our policy on posting correspondence. I can assure you the decision on your e-mail was not taken lightly, but in this case we believe that if posted, the e-mail would serve only to impugn the reputation of dedicated community volunteers and the community association to which they belong.

At the December meeting of the Federation of NV Community Associations, a discussion took place with respect to last fall's unauthorized tree cutting by the GVRD in Lynn Canyon Park. As a result of this discussion, FONVCA passed the following motion:

"THAT FONVCA suggest that Council request from the GVRD appropriate compensation for unauthorized tree removal within Lynn Canyon Park, the amount of which should be based on a pro-rata formula derived from the amount the GVRD paid for the parkland required for the clearance of trees for the water tunnel shaft; and in addition, to rehabilitate the damaged area."

FONVCA notes that the GVRD has been guilty in the recent past of unauthorized incursions onto District lands. It would therefore be an appropriate action by the municipality to seek damage compensation in order to send a message to the GVRD that more care must be taken to ensure these sorts of events do not occur again in the future.
