## 3.2 Shirtsleeve Review of Nov 14th Meeting with Council

Members felt this year's meeting was more dominated by Council than previous meetings. There was a consensus that DNV should get the best possible value out of the old Official Community Plan rather than starting completely from scratch.

There was a discussion on the role of of the Local Area Plans vs. the District wide OCP.

There was a discussion of the respective roles of the Rec Commission and DNV Parks Department. It was pointed out that so far neither the NVRC nor DNV Council has accepted the Needs Study.

It was noted public input has a tendency to take place towards the end of the public process as people tend to react once they believe "their ox is being gored".

## **3.3 Climate Change Presentation (November 6<sup>th</sup> at Parkgate)**

The meeting was held at Parkgate and was attended by the majority of Council. Four "World Scenarios" were presented each more stringent but without much detail. ### 4. Correspondence Issues

### 4.1 Business arising from 13 emails

Corrie submitted an email warning that Development Cost Charges levies with respect to parkland requirement may be substantially reduced (factor of 4 was suggested). The issue is one of sustainability vs.affordability when there is growth.

It was noted that DCC charges are ALL higher in muncipalities that have reviewed their rates more recently than DNV, with muncipalities reviewed <u>before</u> DNV having lower rates. Throughout Vancouver 80% of DCC usage was to buy parkland. It was pointed out that DCCs can only be spent on Council-voted initiatives and must be co-funded from current revenues – it is NOT "free money".

### 5.7 Workshop on Development Cost Charges

http://www.dnv.org/upload/documents/Council\_Workshops/cwm071022.htm In the above staff told council that:

DNV Parkland supply standards used in 1997

- Neighbourhood =1 hectare per 1000 people for neighbourhood park
- Community = 1 hectare per 1000 people for community park
- District = 2 hectares per 1000 people for District park

This standard is very ambitious and not necessarily sustainable at today's land values so may need to be readjusted.

## At this meeting it was suggested that standards for parkland be reduced by 75%
