What is the North Shore Waterfront Liaison Committee?

- **Started in 2009 by Port Metro Vancouver** as mechanism for dialogue between port and neighbouring communities
- **Purpose:** to share factual information, identify concerns, provide suggestions, and facilitate two-way communication about a wide variety of port issues on the North Shore
 - Other port liaison committees are located in East Vancouver and Delta

- Industry representatives (NS port tenants)

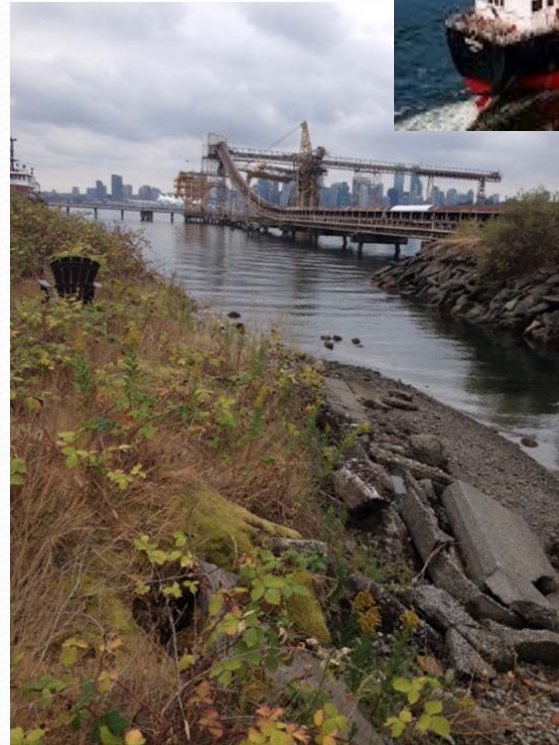
Our commitment as DNV resident reps

- Bring information back into our communities about port-related activities
- Bring questions and comments to committee members from our communities
- Encourage engagement with local residents and businesses
- Support dialogue among the community about port activities and concerns
- Help our communities find reliable info
- Facilitate collaboration between industry, municipalities and community



Recent issues identified by residents brought forward to committee

- **RAIL:** noise related to rail operations (warning whistles and shunting activity)
- **MARINE:** lights and noise related to onboard ship maintenance and discharge from ballast-tanks
- **ACCESS:** preservation of waterfront heritage, public access to shoreline
- **INFO:** Access to development information (transparency)



What has the committee done recently?



- Driven reduction in train whistling
 - Rail Noise Steering Committee
 - Rail crossing changes
- Secured storage for last remaining foreshore cabin
- Participated in educational harbour tours
- Provided feedback on the PMV Land Use Plan
- Attended community Events
 - Coho Festival, Party at Pier
