A lawyer will often send a letter "without prejudice" in case the letter makes admissions which could later prove inconvenient to the client.

3. OLD BUSINESS

- **3.1 Northlands update** Corrie referred to recent articles in Vancouver Sun and Outlook. No word on when committee would meet with council and/or when further meetings would be held.
- **3.2 CANLAN update** Corrie discussed recent notice of counter petition opportunity and lack of details/bottom-line on exactly what liabilities are being undertaken by District. Suggested that proper accountability could be accomplished by appropriate re-notification.
- **3.3 Non-profit leases** Corrie recommended guidelines similar to W. Vancouver's (distributed at meeting) be followed for Deep Cove Yacht Club Marina lease.

Corrie reported on June 11 meeting. Presentation by staff held no surprises as it was largely based on common sense in the ways budgeting could be handled. Pros/Cons of each approach (eg. incremental, zero based, etc) were presented at the workshop.

Your comments were referred to our Solicitors who have advised as follows: The District, subject to the outcome of the counter petition opportunity, has entered into a three-way agreement with the Toronto Dominion Bank and Canlan (the "Tripartite Agreement"). The District is not incurring any liability under the Tripartite Agreement and therefore no counter petition is necessary in relation to that agreement. The Tripartite Agreement does permit the Toronto Dominion Bank in certain circumstances to put a receiver or other part in the place of Canlan. In that sense, the Tripartite Agreement is a related document. As such, it has been made available for public inspection as required by section 177 of the Local Government Act.

The counter petition notice published by the District gives the amount of the annual payment for the 2003 season, states what the

payment is for, explains that the payment must be made each year during the term of the agreement and states that the term of the agreement is 45 years ending in 2048. The notice also explains that the annual payment will be adjusted in each year after 2003 based on the Vancouver average all-items consumer price index (which indices are of course unknowable at this time). The counter petition notice also says that the District will incur a liability to pay in each year during the term all property taxes (if assessed, levied and payable) in respect of the portions of the facility where the public programs are conducted. Thus, the counter petition notice clearly meets the requirements of the *Act* to describe the nature, extent and amount of the liability under the proposed Ice Facility Partnering Agreement.

3. The services to be provided by Canlan under the Ice Facility Partnering Agreement and the District's obligation to pay for those services are coterminous and thus section 33.1(1)(b) has been complied with.

With respect to the form of counter petition, Section 172.5 of the *Local Government Act* sets out certain requirements for the form of counter petition, but there are currently no regulations that prescribe the form and content. The form must include the full name and residential address of the signatory and, if applicable, the address of the property in relation to which the person is entitled to register as a non-resident property elector.

Prior to commencing with our first counter petition process in the District, the form of counter petition was discussed with the Municipal Solicitor. The Solicitor recommended that the form of counter petition to be used in the District for all counter petition opportunities also include the following information:

- Ø A general description of the proposed bylaw, action or other matter to which the counter petition relates;
- Ø A statement that, for the purposes of signing the counter petition, the term "elector" means a person who, at the time of signing this counter petition, meets the qualifications of the Local Government Act for registration as a resident elector or as a non-resident property elector of the municipality of the affected area, as the case may be;
- Ø A statement that accurate copies of the counter petition form may be made and used for signing;
- Ø A statement that a person may not withdraw his or her name from a counter petition after the deadline;
- Ø A statement that a person who presents a counter petition form to another person for signing must not knowingly make any false or misleading statements to the other person about the proposed bylaw, action or other matter to which the counter petition relates, and that a person who contravenes this prohibition commits an offence; and
- Ø The deadline for returning signed counter petition forms and the location where they must be delivered.

Given the fact that all of this information is to be printed on each page of the form, it would be difficult to provide space for more than one or two signatures on the page without reducing the print size considerably. This is not recommended as it would make it more difficult to read. It is my understanding that our form is similar to the form provided by other municipalities. I have attached a copy of the City of North Vancouver's form for your information.

I trust this addresses the issues you have raised regarding this counter petition opportunity.
