Thank you for your inquiry regarding the status of the OCP Implementation Committee.

Please be aware that, as of the 31<sup>st</sup> December 2015, the mandate of this committee expired and this committee has been disbanded. Nonetheless, there may be interest in connecting with these former committee members on a periodic, and as needed, basis.

Staff is currently working to post an online public survey over the summer to gather community feedback on the inaugural OCP Progress Monitoring Report that was developed in 2015 with valuable assistance and guidance from the OCP Implementation Committee and the Monitoring Working Group subcommittee. Once this community input is received, and as informed by Council direction, staff will reconnect with former OCP Implementation Committee members (likely in the Fall of 2016) to assess interest in reviewing the data summary to inform future OCP Progress monitoring reports.
