Meeting called to order at 7:08 p.m.

1. Order & Content of Agenda:

The scheduled presentation by the Chair of the District's "Citizens' Finance & Budget Committee," Mr. Robin Hicks, (item #5 on the agenda) has been canceled. Mr. Hicks is agreeable to attending the June FONVCA meeting. However, it is understood that he will be speaking as an individual resident with expertise in municipal budgeting, and not on behalf of the committee.

2. Adoption of April 19/2001 Minutes:

The minutes were adopted as amended.

3. Old Business:

- 3.1 "Smart Growth" 2 free tickets are available for all-day seminar on June 7th. An evening presentation is also scheduled for the night before on June 6th. No FONVCA volunteers at this time.
- 3.2 Extracts from Hansard on Conflict of Interest
 - Corrie read some extracts from a Hansard document

http://www.fonvca.org/agendas/may2001/hansard.pdf in which the District's solicitor, Mr. Lidstone, spoke about the implications and boundaries of conflict-of-interest legislation, which, it was noted, includes a 30 day time-limit to register a conflict-of-interest complaint. For minor complaints there is the District's own Quality Assurance Committee. It was Mr. Lidstone's opinion that the District ought to create the position of an ombudsman.

3.3 **Report on Meeting with Director of Corporate Services, Dennis Back** – This meeting (attended by Corrie, Brian, Margaret, and Val) was for the

purpose of discussing a new policy with respect to community associations' web links to the District's own web site. It was a very positive meeting. The draft policy (which will go to Council for approval) is permissive of links provided the organizations meet some basic criteria like being a registered community association. Some other requirement are that

- * "external sites do not contain any material that expresses an opinion regarding candidates or referenda questions that are the subject of a local government election, between the first day of the nomination period until following the respective election".
- The District reserves the right to terminate any link at any time; subject to first attempting to contact the owner of the web site and resolve any concerns.

3.4 Eldon Park Tree Management Plan (see http://www.fonvca.org/agendas/may2001/Eldon-Park-Tree-Management-Plan.pdf — Sunset Gardens representative Bruce Ward, was not in attendance, however, Hugh Murray reported that the bank below Pemberton Heights is potentially unstable due to tree loss.

4. Correspondence Issues:

The huge amount of e-mail submitted to FONVCA is now grouped by topic/subject and current submissions (a listing is attached to these minutes). Corrie was applauded for his diligence and hard work in keeping the FONVCA web site up-to-date on a daily basis.

- 4.1 Using NVD Facilities for Electioneering
 Purposes It was alleged that Director of
 Recreation, Gary Young, revealed that both NV
 Councils instructed the rec commission to assist
 the Sports Council in lobbying (using NVD
 facilities such as playing fields) for the YES side
 of the referendum campaign during the '96
 election. This would have been contrary to the
 Municipal Act.
- 4.2 Planning Department Process on Development Variance Permits Brian Platts reported on his email correspondence with the Director of Planning Richard Zerr, regarding what Brian believes to be biased staff reports to Council. As a result of this correspondence, Mr. Zerr met privately with Brian and fellow Edgemont Community Association member, Peter Thompson.

5. New Business:

5.1 Citizens' Finance & Budget Committee Canceled (see above)

- 5.2 Council Staff Relations Dave Sadler reported that the RCMP was called to investigate an incident involving Councillor Ernie Crist and the Assistant Clerk Shanna Burrows. While not being privy to the details, there was a general agreement around the table that the incident in which Councillor Crist was reported to have raised his voice during a disagreement with Ms. Burrows in her office should have been settled in-house by the Human Resources Department. It was also agreed that while the behaviour of Councillor Crist is not to be condoned, calling the RCMP and subsequently a lawyer to investigate seemed unnecessary and contrary to written procedures.
- 5.3 Overview of May 8th Briefing with Price-Waterhouse-Coopers Margaret Fraser attended this meeting and made a presentation (to FONVCA) on the main points presented to Council. It was noted that Richard Zerr will now be appointed to Director of both the Planning and Engineering departments. FONVCA members were reminded that a full presentation will be provided to the community associations on May 30th at the District Hall.

6. Other Business:

- 6.1 A discussion ensued over Councillor Harris using
 once again the word "seawall" instead of
 "trail" when referring to the Waterfront Plan.Letters, e-mails and faxes have been sent.

 Maureen reported that Harris has repeatedly been asked to retract this falsehood yet she refuses.
- 6.2 GVRD Mega-City? -- Dave Sadler noted that on May 29th is a presentation/workshop to explore the pros and cons of amalgamating municipalities into one large metropolitan center like Toronto. The event will be held at the SFU Harbour Centre, Downtown beginning at 6:30 p.m.
- 6.3 Cathy Adams suggested that FONVCA continue to meet during the summer months. Cathy will book the meeting rooms, which can always be canceled if not enough people can attend.
- 6.4 Very brief discussion on proposal by United Properties to redevelop into multi-family the recreational Larco site in Lower Capilano. Some comments were made regarding whether or not the site would be appropriate for the long-awaited community centre. Limited traffic access is a problem.
- 6.5 Various handouts were distributed.
