Division 5 -- Reporting

Annual municipal report

- **98** (1) Before June 30 in each year, a council must
- (a) prepare an annual report,
- (b) make the report available for public inspection under section 97, and
- (c) have the report available for public inspection at the meeting required under section 99.
- (2) The annual report must include the following:
- (a) the audited annual financial statements referred to in section 167 (4) for the previous year;
- (b) for each tax exemption provided by a council under Division 7 [Permissive Tax Exemptions] of Part 7 [Municipal Revenue], the amount of
- property taxes that would have been imposed on the property in the previous year if it were not exempt for that year;
- (c) a report respecting municipal services and operations for the previous year;
- (d) a progress report respecting the previous year in relation to the objectives and measures established for that year under paragraph (f);
- (e) any declarations of disqualification made under section 111 [application to court for declaration of disqualification] in the previous year, including identification of the council member or former council member involved and the nature of the disqualification;
- (f) a statement of municipal objectives, and the measures that will be used to determine progress respecting those objectives, for the current and next year;
- (g) any other information the council considers advisable.

Annual meeting on report

- 99 (1) The council must annually consider, at a council meeting or other public meeting,
- (a) the annual report prepared under section 98, and
- (b) submissions and questions from the public.
- (2) The annual meeting must occur at least 14 days after the annual report is made available for public inspection under section 97.
- (3) The council must give notice of the date, time and place of the annual meeting in accordance with section 94 [public notice].

Brian:

James Ridge has asked that I reply directly to your question as to whether or not the District has taken steps to protect itself from possible legal action in the event of an accident involving the elevated walkway.

One of our principle goals in the review of building permit applications is the health and safety of the public. If we are successful in achieving that goal we will have also have succeeded in protecting the District from possible legal action. In that regard there was an extensive pre-issuance process including receipt and review of arborist reports and engineering design and documentation. We required (and received) a structural concept review by an independent third party reviewer. We required the structural engineer of record to review and take responsibility for the entire design including capacity of soils (geotechnical), competency of the support trees as well as the structure itself. The contractor pre-loaded the structure to confirm that deflections were within predicted and acceptable allowances. We are in receipt of the professional Letters of Assurance with respect to the structural aspects of the work. The letters confirm both design compliance with code requirements and that the work has been installed and inspected per the issued plans.

The District has completed its compliance monitoring process and is satisfied that the Building Bylaw requirements have been satisfied.

With respect to protecting the Districts interests, the District's liability insurance provided through the Municipal Insurance Association would protect it from any possible legal action. Our primary goal, however, is to protect the health and safety of the public and I am satisfied that the review and monitoring process have achieved that objective.
