# 3. Old Business

#### 3.0 Shirtsleeves meeting with Council

The meeting is to be held on Tuesday, 05/29. The topic suggested by FONVCA is: public involvement/process protocol. No alternatives were suggested by Mayor and Council. The meeting will be co-chaired by Council and FONVCA

An added topic: OCP's, District and Local Area Plans (incl. Housing Initiatives etc).

#### 3.1 Translink parking tax

There will be no parking fee anymore, but the GVRD assessment is up by 43% for DNV taxpayers.

#### 3.3 Smart Rail Group & Canexus

It is unrealistic to have municipalities decide what hazardous material goes through their jurisdictions. This is governed by federal and provincial laws only. The risk of hazardous good moving through

municipalities was discussed, as was the Canexus safety.

The Port of Vancouver is to decide on 05/29 regarding the Canexus expansion.

# 4.0 Correspondence Issues

### 5.1 Powers of BC Transit Act

It was agreed that the DNV is being unfairly taxed by B.C. Transit. Corrie made a motion, which passed with consensus, to send a letter to Council to get fairer and more equitable treatment of DNV in respect of the B.C. Transit tax as per #18-3-E of the B.C. Transit Act. (ACTION)

# 5.2 Recreational Needs Assessment Survey

Some, but not all community associations were invited to a meeting on May 8th.

Objections were made to certain statements made in the report.

Although it appears that there is higher interest in outdoor recreation than indoors, the emphasis in the report is strictly on the facilities. The report was criticized for not being realistic at all. A suggestion is made to sell land for private uses.

The report leaves a number of unanswered questions.

#### 6.1 Legal Issues

#### 6.1.a - Executive Members of Community

**Associations** – A Community Association Chair should not be in a position of having a conflict of interest. It is a fact that some associations are one-issue associations or were founded for one sole purpose.

# 6.1 b – 'Gifts' from developers to members of Council

It was speculated as to what was the reason for a number of mayors' trip to the PRC? A developer in China seemed to be showing off by inviting many mayors from B.C., which is very prestigious in China.

#### 6.1 c - 'Working Groups' and closed meetings

Committees should be open and not closed to the public. In West Vancouver committees have been renamed 'Working Groups' to apparently circumvent the open meeting requirement. The Community Charter requires that "open meetings" apply to the entire range of meetings held by local government bodies.

At the FONVCA meeting of May 17<sup>th</sup> 2007 a discussion took place of the powers of the BC Transit Act. According to this Act Translink (with the authority of the Lieutenant Governor in Council), appears to have the authority to allow different tax rates/caps for different regions (see section 18-3-e of

It was the unanimous request of FONVCA members present at the May 17<sup>th</sup> meeting to request that DNV council examine the validity of this aspect so as to allow Translink to impose a more equitable property tax on the residents of the North Shore. In essence we seek council's support to reduce the property taxes collected by Translink to be more in line with the benefits that Translink bestows upon this region. As it currently stands the North Shore is unfairly subsidizing the rest of the Lower Mainland through the Translink property tax assessments.

Dear Corrie,

I am writing in response to your email to Agnes Hilsen regarding Council's decision to waive the Public Hearing for the zone-amending bylaw that would enable the Corner Store at the property at 2230 Lloyd Avenue to carry out some additional accessory uses including an accessory café use. As you are aware the Local Government Act enables a local government to waive the holding of a public hearing if the proposed bylaw is consistent with the official community plan. At law, the test for consistency is that there is no "absolute and direct collision" between the proposed bylaw and the official community plan.

District staff have reviewed the proposed bylaw in detail with the official community plan, and have consulted legal counsel, and remain of the view that the proposed bylaw is consistent with the official community plan. In this regard the decision of Council to waive the Public Hearing, in this instance, is within the parameters specified in the Local Government Act. I would like to thank you for your input in this matter as these type of meaningful comments assist in current and future decision-making processes.

## Protection provided by an OCP

*Local Government Act*, s.875. Municipalities are authorized to pass an OCP by bylaw under the *Local Government Act*, s.876. Note that once an OCP has been passed, all subsequent bylaws and works of that municipality must be consistent with it (*Local Government Act*, s.884(2)). Courts are slow to find such inconsistencies, however. For example, a court will only find a conflict between a zoning bylaw and a general statement of purpose in an OCP if there is "an absolute and direct collision" between them (Locke J. in *Rogers* v. *Saanich* (1983), 22 M.P.L.R. 1 (B.C.S.C), quoted in *Brooks* v. *Courtenay (City)* (1991), 78 D.L.R. (4<sup>th</sup>) 662 (B.C.C.A.)). Similarly: "In deciding whether a bylaw conforms with the official plan, a plan should be given a broad liberal interpretation" (Rogers, quoted in *Botterill* v. *Cranbrook (City)*, [2000] B.C.J. No 1658 (Online : QL), at para. 44).

So to ensure that uses/densities will not expand beyond those intended in the OCP one needs to include statements like – "all other uses are forbidden" in the zoning bylaw. To simply list allowed uses is not enough.

From <u>http://www.guildyule.com/news/papers/Legal%20News%20Dec%2005.pdf</u> :*It has been held that a zoning bylaw will not be held to be invalid when it sets out a land use contrary to the OCP unless there is an absolute and direct collision between the OCP and the zoning bylaw.* 

Thus it behooves a community to write explicit and absolute restrictions in their zoning bylaw since OCP's are usually silent on the specifics of zoning.
