- less accountability
- more restrictions on FOI
- fewer referenda opportunities
- negative billing type of "assent" (10%)
- more reasons to have closed meetings (eg discussion of reasons to close!)
- removal of many 2/3 majority council requirements
- power to expell councillors from meetings (133)
- lengthens loan authorizations to 30 years
- can undedicate parkland without a referendum
