Discussion Topics

Proposed – in the form of a question to Council:

Encroachments on the Waterfront – an update on the state of the current policy, is requested.

Proposed discussion topics:

- 1. **Sewage treatment plant** specifically the issue of amortizing it over 15 years, versus the 40-50 year lifetime of the facility. A longer term would ease the tax increases. Discussion of various options for different treatment types (eg. quality of targets, planned inflow characteristics, and means to achieve secondary treatment).
- **2.** Renewal of Recreation facilities and the Recreation Commission Agreement and governance of recreation facilities
- **3.** Park users the issue of "We pay, you play"/District residents pay for parks that are heavily used by non-residents, with no recovery of costs
