

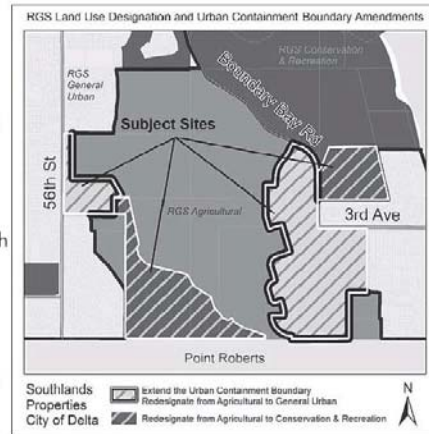
## NOTICE OF PUBLIC HEARING – Thursday May 1, 2014

Notice is hereby given that a Public Hearing will be held pursuant to the provisions of the *Local Government Act* to consider Greater Vancouver Regional District Regional Growth Strategy Amendment Bylaw No. 1203, 2014.

The Public Hearing will be held on Thursday, May 1, 2014 at 11 am in the 2nd Floor Boardroom, 4330 Kingsway, Burnaby, BC.

Greater Vancouver Regional District Regional Growth Strategy Amendment Bylaw No. 1203, 2014 (Bylaw) would amend the regional land use designation for portions of a proposed development site in Delta, referred to as the Southlands Properties, from Agricultural to General Urban and Conservation and Recreation and extend the Urban Containment Boundary to encompass the new General Urban area. A map of the site is shown with the proposed changes included.
