Chilliwack Announces Trio of Community Projects

By City of Chilliwack

CHILLIWACK – Mayor Clint Hames announced plans today for three community projects. These are the construction of a new Chilliwack Cultural Centre, the renovation and upgrading of the Cheam Centre, and the installation of a synthetic turf sports field at Townsend Park. The trio of projects is slated to begin before the end of the year.

A Request for Expressions of Interest (RFEI) has been issued to identify qualified companies with the experience, resources and skills to design and construct the new Cultural Centre. A similar RFEI has been prepared for the Cheam Centre project, and will be released shortly. The synthetic turf field bid package is currently being prepared and will also be released in the next few weeks.

"The City of Chilliwack is committed to meeting the leisure needs of its citizens. These projects demonstrate our maturity as a community, one that recognizes the importance of having a diversity of cultural and recreational opportunities," said Mayor Hames.

The Chilliwack Cultural Centre project is a \$22 million plan to build a state-of-the-art cultural facility in the heart of downtown Chilliwack. The Centre will include an art gallery, a 500-seat performance theatre, a 150-seat recital hall, a 200-seat studio theatre, music instruction rooms, arts and crafts studios and related amenities. It will be located on City-owned land at The Landing, adjacent to existing sports and recreation facilities and Prospera Centre. The City will also be adding 4,000 square feet to the Chilliwack Archives portion of Evergreen Hall to meet the demand for space. Construction is expected to begin in April 2008 with completion in 2010.

"Chilliwack has a thriving arts community, with dedicated and talented individuals who've worked hard to grow programs and events. With the right facility, we can create extraordinary opportunities to support and nurture arts and culture in the community," said Mayor Hames.

The Cheam Centre Renovation plan is an \$8.5 million project to redevelop and upgrade the existing Centre into a high-quality community recreation destination. Plans include construction of a new six-lane 25 metre pool with change rooms, an administration area, storage rooms, and improvement of existing spaces. The existing swimming pool and curling rink will be demolished. The first phase of reconstruction is expected to be underway in June of 2008 with substantial completion in summer 2009. A fitness facility upgrade is planned as a second phase budgeted for 2012.

"Convenient access to facilities is a priority for the City," said Mayor Hames. "The Cheam Centre renovation will create a focal point on the South side of Chilliwack and complement existing facilities across the community."

The synthetic turf field at Townsend Park will replace the existing grass field 'A' and will accommodate a full-size soccer pitch, a Canadian rules football field and most other field sports. The \$2 million project will provide all-weather access to sports field users and reduce maintenance costs associated with grass fields. Synthetic turf is considered to be the most cost-efficient way of providing the maximum number of users the opportunity to play on a high-quality field that remains constant regardless of weather. Installation will begin in the Spring of 2008 and the new field is expected to be in use by the Fall of 2008.

Said Hames, "Chilliwack plays host to a number of sporting activities that will benefit from the installation of synthetic turf, including minor soccer, minor football and field hockey. Many communities throughout the Lower Mainland are moving toward this new standard. The installation of the synthetic turf field will give our young athletes the opportunity to play on fields that is fast becoming the standard across North America, and continue to keep Chilliwack on the leading edge."

These projects are included in the City's 10-year Comprehensive Municipal Plan. No borrowing is anticipated. The City will finance the Cultural Centre project with some assistance from cultural partner groups, service clubs, private sector supporters, and federal and provincial grants. As well, the City has applied for federal cost-sharing for the Cheam Centre Renovation. The synthetic turf field is also budgeted for 2007/08 as part of the City's 10-year Comprehensive Municipal Plan.

"Residents of the City of Chilliwack deserve the finest in community amenities. Our goal is to provide the best possible facilities within the most responsible financial framework," said Mayor Hames.

5.6 Governance: Global Actions and Visioning

Corrie to give summary of WV presentation by Martha Piper & Michael Byers

This free meeting was sponsored by West Vancouver Citizens for Good Governance (WVCGG) and was held 7:30pm Nov 1/2007 at the Key Meek Studio Theatre, 1700 Mathers Ave in West Vancouver. It was well attended – however I could not find anyone I knew from NV that was present. This meeting was in no way connected to "rating" politicians but was on the general issue of what constitutes "good governance".

Dr. Michael Byers (researcher in international law and politics at UBC) – hailed from Lethbridge Alberta, and as a 15 yr-old campaigned successfully to reduce a 500 home development planned to go into a river valley to about ¼ of that scope. Lesson: One can make a difference. He described some "connections" – the first was putting to bed any doubt about climate change - amply demonstrated by trends and expectation that the artic ocean – some 1.2million sq-km will be ice-free within 10 years. It's not the melting that will raise the level of oceans – it's the expansion of water due to temperature increase that will dominate. This will impact the West Vancouver waterfront residents. The second connection – drugs in downtown east Vancouver, the war in Afganistan, and property crime in Vancouver – which currently is second in North America only to Miami. He suggested Canadian government buy the harvested drugs directly from Afganistan. Municipal governments need to get directly involved in such issues – especially as they are more nimble and flexible – and thus become leaders in dealing with the impacts of climate change. He noted that Chicago is the leader in CO2 reduction, while Norway is expected to be CO2 neutral in coming decades. "Think big or we won't be able to thing small"!

Dr. Martha Piper (past UBC president) indicated **that it takes more than talent to tackle climate change – it takes nerve and hard work.** Crafting of the vision was critical – giving focus to a community. There needs to be tension between consulting and the required action. Consulting means listening and perhaps agreeing, but perhaps not. Not every issue needs to go to referendum. She described the Aesop fable "Bell the Cat" <u>http://www.bartleby.com/17/1/67.html</u> - the message being that "it is easy to propose impossible to implement remedies". Piper felt the need to align day-to-day municipal workers with the "vision" – say by changing/restructuring the various committee organizations so they all work towards the same common goals/visions. An annual hardcopy "scorecard" to keep accountability on track was essential. [*message here to DNV council!*]. The impact of "industrialization" was likened to the earth being struck by a giant meteor – except it's happening more slowly.

It was suggested that, with practice, writing letters to the editors of newspapers can have an impact. It was suggested that governance policies should be set by a "board" and not the public. The king of leaders we need are those who believe and practice that "Good governance means telling the truth even if they do not want to hear it"!

After the meeting I asked Martha Piper if she felt whether it was appropriate to only put the annual report of a municipality on a web site and not make it available in hardcopy format. She agreed that this was NOT appropriate and that **hardcopies are an essential element of an annual report**.



Mr. Kost: Our regional utility planning folks have provided the following information in response to your query:

- the total GVWD withdrawals from the three GVWD watersheds (Capilano, Seymour, Coquitlam) in 2006 averaged 1,160 million liters per day;
- the total average annual renewable water flowing into the three GVWD reservoirs (Capilano, Seymour, Coquitlam) is about 5,250 million liters per day;
- \cdot therefore about 22 percent of the total water captured by the GVWD reservoirs is consumed by the GVWD and about 78 percent flows to the oceans.
- \cdot Note that the BC Hydro withdrawals from Coquitlam Reservoir flow into the ocean at Indian Arm.

Re: Right to Know Week

I am writing in response to the two questions you have raised in your e-mail of September 29, 2007 with reference to "Right to Know Week".

Does the new Lynn Valley Library/Town Centre meet 2005 Earthquake Specifications?

In order to receive a building permit the Lynn Valley Library had to be designed in accordance with the 1998 BC Building Code. However, the design team was aware of the potential changes that were under consideration for the 2006 BC Building Code and these were taken into consideration. For example, although not required under the 1998 code but included in 2006 code a Dynamic Analysis of the project was completed to understand how the building would respond to a design earthquake. The team was also aware that the seismic values proposed for the Vancouver region in the 2006 code were similar to the design values in the 1998 code and as a result the design parameters would be similar.

In short, the engineering analysis completed for the Lynn Valley Library/Town Centre would measure up favourably when compared to the 2006 code.

Does the new \$600 million water filtration system for the Seymour/Capilano reservoirs deal with very high turbidity events that are expected due to climate change?

The new filtration plant has been designed to handle turbidities that have historically occurred in the Seymour and Capilano water supplies over the last several decades, including the event that occurred last November (short tem turbidities of 50 to 90 ntu). The plant has been designed to increase its turbidity removal capacities by adding a sedimentation (solids removal) step ahead of the filters, and space has been provided during construction to do so.

Therefore should climate change result in much higher water source turbidities in the future, the plant can be modified to handle approximately 10 times the recent turbidity levels which will be more than adequate.
