3. Roundtable on Current Affairs

- Butler raised ongoing stream issues in Seymour
- Goodman raised ongoing (mostly waterfront access) issues; not much progress in Deep Cove
- Curran raised gaps in planning process related to Lower Capilano
- Kost advised of upcoming EUCCA AGM October 24th at Capilano Library at 7 pm
- Belhouse advises not everyone knows about Delbrook issue; phoned Rec Commission to set up table at 30th Anniversary of Delbrook and told it was too political; advised any advocacy must be approved by staff – issue must be clarified/resolved; Delbrook has no park; ongoing issue with lack of engagement with residents by DNV

• Discussion on Recreation Commission; queried RecCom reporting structure and influence in the OCP process.

To Mayor and Council,

Noted today was another appeal directed to the CGA from DNV Administration, asking for help in engaging the community in the Street Naming Contest for the new streets coming into being through the Town and Village Centres. A few weeks before there was a request for feedback and engagement in the Budget Directions and Policy workshop at District Hall.

Our group does not see these requests as unwanted or troublesome, but in fact as the opportunities they are for community-wide contact. We view this as part of the legitimate functions of any group calling itself a community association. By making these requests it is also apparent that the Administration view these functions as useful to the full scope of DNV operations and resident well-being.

In this light it remains troubling that in removing oversight of CAs, Council did not provide for the opportunity for mentoring and reshaping a renewed vision for its community associations. This was the basis of the request from the CGA's Executive Board, previously presented to Council (attached).

We have heard that Community Associations "can be anything they want to be" and "there are many different types of community associations". What is lacking is an appropriate structure through which residents, Administration and Council be able to reliably engage with CAs and be able to confidently assess the context and appropriateness of those organizations. It is important that CAs be given guidance and reference points by which to examine their operations and goals.

We remain confident that time and events will indicate the need for clear model(s) and structure of community associations, and result in better decision-making and public engagement in the future.

We would like to address the recent decision by DNV Council to remove District Administration of the duties of governance and oversight of Community Associations.

This decision was heavily based on a staff-produced paper, "Community Associations in DNV: Discussion paper", (Appendix A). Significantly the paper states that the material within it excludes any discussion of the value of community associations. Additionally, the document concludes that consideration should be given to the mutual benefits to the relationship between DNV Council and residents through Community Associations (CAs).

Although promised, there was no consultation with community leaders to explore opportunities for constructive changes in the policy regarding the operations of CAs.

We believe that the long-established criteria (Appendix B), although requiring revision, provided a foundation for CAs to act as responsible conduits and facilitators of information and services to their community. Through clarifying the role and mandate of CAs the opportunity exists to enhance the public discourse and citizen and community engagement across the DNV.

There exists a significant opportunity through well-founded and engaged CAs to leverage the dedicated volunteer time and enhance collaboration between all stakeholders in our communities. The benefit and cost saving with this level of engagement and with a "healthy community" focus, far outweigh the cost to DNV of administrative support of CAs. Reporting and monitoring of activities required of CAs could be self-administered through standard web-based tools further reducing staff administration duties.

We propose that DNV and Council:

Clarify and expand upon the Corporate Policy, "Community Associations - Criteria for Official Recognition" to ensure:

- Community Associations are properly established, governed and guided to have the ability to improve public, social discourse and healthy community initiatives across the DNV.
- 2. The mandate and primary role of a Community Association is to engage and provide information, to all residents, business owners and property owners within a defined geographical area. That Community Associations also have a key role in:
 - Partnering with DNV and community program/service leaders to create a sustainable infrastructure for collaborative information sharing based on factual, informed, best practice for capacity building and change in all our communities.

- Supporting development, collaboration and coordination of programs and service provision for community residents, property owners and business owners for the ongoing development of healthy communities.
- Leveraging the work and support of NGOs, volunteers and corporate sponsors to build capacity for ongoing services and operational priorities for youth, seniors, and families.
- 3. Establish a working group of community leaders who wish to work with their communities based on this revised role for Community Associations.
 - Provide resources for a "change manager" to support this effort and also to work with community groups and associations to transition to this new model.
 - Maintain this support on a permanent basis.
 - Develop a "tool kit" that supports the development and ongoing operations of volunteer community associations to include;
 - A standardized template for a community website
 - Tools for event planning
 - Links to resources for community support and communications

We look forward to the opportunity to re-engage the discussion of the proper role and operations of community associations as credible partners in the community fabric of the District of North Vancouver.

"This brief discussion paper will not address the value of community associations; instead, it will accept their existence as a given and analyze the range of engagement options."

"Consideration of different levels of recognition and engagement should address the mutual benefits of the relationship, existing or enhanced community resources to support associations, and the ability of the District to devote limited resources to administering different levels of engagement.

A review of community associations by Council would be an appropriate opportunity to fully address the myriad of issues District staff and community members have on this important matter. "

Explanation of the decision FONCVA meeting June 20th subsequently supported at the DNV Council Meeting on July 23rd, 2012

Mr. Stuart indicated that staff had reviewed the current policy regarding accreditation of community associations and given the wide variety of associations and the improvements in District's community engagement approaches, concluded that there is little value in acting as a gatekeeper certifying associations, particularly as many cannot or do not purport to represent the residents views in a particular area which was one of the goals when the program was first introduced.

This matter was discussed with Council who directed Mr. Stuart to ask FONVCA if this gatekeeper role was one they wanted to take over. After some discussion the FONVCA Executive declined.

The District will continue to make links on the District's WEB site to the many groups and associations in the community who are involved in a wide variety of activities but will not represent them as being "certified" by any accreditation process.

It is an affront to Canadian citizens that RCMP Sergeant Don Ray received a 1-rank demotion, transfer and docking of 10 days pay. His admitted conduct would result in <u>instant termination</u> by every respectable corporation in this country.

Your government has spent much time and effort on issues of crime and consequence, but I see no results in addressing widespread moral rot in policing, the most basic element of our justice system. Dear Mr. Ellis:

The Office of the Prime Minister has forwarded to me your correspondence of May 25, 2012, regarding the accountability of the Royal Canadian Mounted Police (RCMP). I apologize for the delay in responding.

Along with a storied history, the RCMP has also faced great challenges. Canadians' confidence in the organization has been tested over the past few years. It is clear that changes are needed to restore the RCMP's reputation as a world-class police organization.

In November 2011, we appointed Mr. Bob Paulson as the new RCMP Commissioner. A senior police leader with extensive experience across the RCMP's complex mandate, Mr. Paulson is well positioned to deal with the challenges associated with maintaining the RCMP as a key Canadian institution.

While we have seen progress in several areas—for example, the provinces and the territories recently signed new 20-year RCMP police service agreements which address key issues such as governance, accountability, program sustainability and cost containment, for example—more needs to be done.

The *Royal Canadian Mounted Police Act* has not been significantly amended for over 25 years. It became clear through my discussions with the Commissioner, and with Canadians, that changes are needed. Accordingly, on June 20, 2012, I introduced new legislation in the House of Commons to enhance trust and accountability in the RCMP.

The Enhancing Royal Canadian Mounted Police Accountability Act will:

• Help modernize the RCMP's discipline, grievance and human resource management framework, including new measures to create a single, seamless and comprehensive investigation and resolution process for sexual harassment complaints within the Force. It also provides the Commissioner with the direct authority to discharge members for various non-disciplinary administrative reasons;

- Create a modern and independent Civilian Review and Complaints Commission to replace the existing Commission for Public Complaints Against the RCMP and provide it with enhanced powers to carry out its mandate;
- Enshrine in law the requirement for investigations of serious incidents involving RCMP members to be referred to other police agencies, where one exists.

Right now, the RCMP discipline process is overly rigid and bureaucratic. Proceedings tend to be drawn out over years in most instances. Front-line managers have very few options to address misconduct. Not surprisingly, this tends to create an adversarial work environment with significant delays in disciplinary action.

Under the new legislation, managers will have more tools at their disposal to respond. In cases where dismissal may be an outcome, the manager or commander would be required to refer the case to a conduct board. However, those boards would be significantly different from the current adjudication boards in that they would have the discretion necessary to consider and resolve cases in the most informal and expeditious manner as possible under the circumstances.

The focus will be on having the vast majority of issues addressed at the most appropriate level in the RCMP in a timely manner and by managers who are most familiar with the situation.

When it comes to the serious issue of harassment, we know that processes alone will not solve the entire problem. Attitudes need to change. This change has already begun, as seen by the recent training of new harassment investigators in the province of British Columbia. This is a good start, but more has to be done.

As Minister of Public Safety, I have had the privilege to meet RCMP officers and staff across the country. I have also witnessed the pride and the appreciation that Canadians have for the men and women of the RCMP. This new legislation will be important in ensuring that the RCMP remains an accountable, trusted and adaptive organization for generations to come.

While my role and responsibilities prevent me from commenting on the specifics of the case you mention, it is my hope that you find the above information useful.

Thank you for taking the time to share your views.

An open letter to Lower Capilano area residents:

On October 12th, the North Shore News published an <u>error-ridden article</u> on planning for the Lower Capilano Village Centre. At last night's CGA "Bench Session" held at 1829 Capilano Road, a number of residents expressed alarm at total living unit numbers mistakenly assigned solely to Larco's Capwest site, due to the misleading NS News article.

For the record:

- Actual living units for the Larco/Capwest site is estimated at 380 400 units, not 1,224. Final number is dependent on ongoing designs, but overall density is restricted to OCP guidelines and can not be more than 2.5 FSR..
- the <u>total number of *theoretically* possible living units</u>, on all **22** (Yes, 22!) commercial properties falling within the official Village Centre Boundaries would be 1,224. This is based on densities of 1.75 FSR (C9) zoning and 2.5 FSR on those properties that have a change of use and density, ie; Grouse Inn.
- among the 22 properties included in the area plan is the PetroCan station, Denny, Earl's parking lot, Travelodge, North Vancouver Hotel and Kal Tire sites.
- the 1,224 figure includes properties such as an existing mixed use C9 building at 1629 Garden and an existing multi family building at 1644 McGuire. Other sites such as the PetroCan are unlikely to redevelop at least until there is no more gasoline to pump.

• without property consolidation, many of the 22 properties falling within the plan would not be able to achieve these densities, due to other planning and site coverage requirements. As currently configured, a number of the existing Capilano Road properties would not be able to achieve even their present zoning of 1.75 FSR

All of the above figures reveals both the degree of complexity involved in planning and the need to be accurately informed and actively engaged in plans for your community.

The above article misses a number of significant aspects of the proposed Village Centre and confuses the ownership, unit numbers and geography of the development in a manner that would tend to unbalance the opinion and understanding of a casual reader.

The article fails to mention the significant community amenities will be provided to the neighbourhood through the development of Larco's Capwest site, not to mention the further benefits not yet determined from the Grouse Inn and other properties slated for much needed refurbishment.

A 22,000 sq. ft. community centre, a revitalized and landscaped Fullerton Avenue with safe legal sidewalks (there are none at present), desperately needed seniors rental apartments, a public plaza with seating and meetings spots will revive a neighbourhood made inclusive and accessible via improved trails and a pedestrian-oriented street.

All of these amenity components - for which neither the DNV or its taxpayers have an appetite to pay for directly through increased taxes - are becoming available through the redevelopment of a site that has sat vacant for many years and offered no benefit to the community or enhanced the DNV tax base.

The revitalization of the motel properties would begin to offer tourists the level of accommodation they desire. Presently the owners of the Capilano motel properties watch busload after busload of tourists pass their doors on the way to the Capilano Suspension Bridge and then return to hotels in the downtown core.

The Capwest site, while comprising 4.35 acres, occupies a much smaller footprint than described by your reporter. Also, many of the 1,000 living units cited by the reporter would replace a large percentage of the dated motels rooms that continue to sit at vacancy rates below 60%.

While objections will remain from those who believe that the automobile should be accommodated above all, I wish that Mr. Miller had been available at the planning event to hear the young mother relate to me the decision made by herself and her husband to purchase and settle a few streets east of the proposed Village Centre.

For this young family, the prospect of the Village Centre with its promise of energy, social connection and community centre cemented their decision to purchase here, as a place with a future that meets their future and growing family needs.

At the last FONVCA meeting a number of concerns were raised regarding the high costs of bike routes and other bicycle friendly initiatives. Key to increasing the number of bicycle commuters and recreational cycling is providing safe and dedicated bike lanes such as seen in Denmark, Amsterdam and other European cities, many of them with weather patterns similar to ours.

The lack of dedicated bike lanes, forcing cyclists onto the same road surface as cars essentially places the cyclist's safety far below that of the convenience of automobiles, in effect devaluing the lives of cyclists.

As the attached study on automobile use makes clear, many of the costs of automobile use are externalized and borne by others, not the owners, who in many instances are not given incentives to reduce "low value" trips, ie; a single occupant traveling along a route serviced by transit.

As the study explains "...a significant portion of driving has relatively low value to the user, either because the trip itself provides little net benefit or because alternative modes exist. Increasing prices to reflect a greater portion of total costs would reduce low value driving, improving overall transport system efficiency.

A number of transportation price reforms could reduce current distortions that encourage excessive automobile travel.¹⁴ For example, making automobile insurance a variable cost could reduce driving by about 10%.¹⁵ Offering employees cash payments as an alternative to free parking typically reduces automobile commuting by 20-40%.¹⁶..."

A broad discussion of the variables involved in all modes of transportation might provide context and perspectives useful to FONVCA and DNV citizens.

While some will argue that the level of bicycle use does not warrant the costs of expanding safe cycling lanes, cycle use will increase dramatically once the cyclist is not asked to continually put their lives on the line every time they take to the road.

Most of the costs of automobile use are externalized and borne by others, not the owners, who in many instances are not given incentives to reduce "low value" trips, ie; a single occupant traveling along a route serviced by transit. Interesting news article from our community newspaper, from our North Shore Safety Council AGM, recently, of which I am a member. Dr. Gutman emphasized that supervision was advised for these growing extreme sports that place such a burden on us, especially on the North Shore! More reason to contain the sport of mountain biking inside a private recreational resort and enforce it. DNV cannot supervise the mountain biking sprawl across the public forest at all. Sanctioning this free ride sport on public forest land, while also aiding and funding more new (and unsanctioned?) trail building for mountain bike use has only added to the rising injury rate, and more serious injuries coming out of this sport. Can this be called wise or responsible "planning", in light of the following facts? *North Shore leads B.C. in fall injuries* CapilanoLake0352-cmweb.jpg By North Shore Outlook Published: *November 08, 2012 09:00 AM* Updated: *November 08, 2012 10:510 AM*

With some of the country's lowest infant mortality rates and highest life expectancies, it's what North Shore residents are doing with their time in between that has local health professionals shaking their heads.

According to Vancouver Coastal Health, the North Shore suffers the province's highest rate of hospitalization from falls, both at home <u>and recreation related.</u>

<u>*"It's higher than in any other health authority across the province,"* said VCH</u> active living coordinator JoAnne Burleigh at the North Shore Safety Council AGM last week.

The topic of the Nov. 1 meeting was 'dealing with risk-taking behaviour,'

particularly among young people, and the keynote presentation was delivered by Lions Gate Hospital emergency physician and medical consultant http://www.rockdocinc.com/> for mass gathering events, Dr. Sam Gutman.

"The North Shore experience is vastly different from the other hospitals in the Lower Mainland," Gutman said. "I know the weather when I'm on a shift — and if you've been to Lions Gate you know there's no windows in the emergency [room] — but I know the weather based on what's coming in the door. So, I know when there's ice on Grouse Mountain; I know when it's freezing rain."

And it's not just during the winter months that people on the North Shore are the most accident prone.

Gutman joked that his favourite time of year, despite the weather, tends to be from October to November because of the brief lull in injuries it affords as people who live and recreate on the North Shore transition from one high-risk sport to another.

"It's the only two-month period when it's quiet. There's less mountain biking, there's no snowboarding. The number of risk behaviours drops precipitously and we actually see it in our volumes of patients," Gutman said.

"But I know that by the third weekend of November, I'm going to start seeing broken wrists and concussions from the slopes *and I know that probably around March or April I'm going to start seeing mountain bike injuries."*

<u>*From the latter category, Gutman said 53 per cent of mountain bike injuries</u> happen to those 20-39 years old, with 81 per cent of injuries occurring in males.*

Young men are especially hardwired hardwired to take risks and put themselves in danger, Gutman said, *comparing a young man's compulsion towards careless behaviour with an addiction to drugs or gambling.*

"Physiologically they are impelled to do this. It's not even a choice situation," Gutman told the health-and-safety gathering.

"It's evolutionarily adaptive," he continued. "When the young male is doing preening behaviour or trying to attract a mate or trying to survive to procreate the next generation, being able to go out and attack that tiger is an adaptive thing. And the ones who aren't very good at attacking the tigers, don't survive."

However, Gutman stressed risk-taking behaviour isn't unique to any one age group or gender, and said we should focus on channelling the natural risk-taking tendencies we all have into positive "smart risk" activities that will benefit our health over time.

"In terms of chronic disease, which is the epidemic of the next 20 years, activity is the single largest modifiable factor," he said.

"We have to make a decision as a society: Are we going to focus and invest in lifestyle or are we going down the same path that has led us to an epidemic of chronic disease?"

Saskatchewan has three Acts ensuring freedom of information all by itself, not including applicable federal legislation.

If everyone was really in favour of transparency, would we really need all this legislation? Freedom of information is much like freedom of speech, everyone is in favour of it until it makes us uncomfortable. Legislation seems less about providing information than ensuring those who have it are not made too uncomfortable by those who want it.

Freedom of information legislation starts by assuming everything is a secret and then details the exceptions, culminating in a list of what information the public can see. Sometimes, this list is framed as a citizen or customer information bill of rights. This sounds good but it's upside down.

Effective legislation would start with the opposite assumption, building on the foundation that everything is public. Something like: If it's in our files, you can see it.

Then, describing three of four exceptions with rational reasons for keeping this information from view. In other words, the burden of proof would be on those wishing to keep things a secret, not on those demanding disclosure. This would have the added benefit of making legislation a good deal shorter.

This reverse burden now plays out in day-to-day operations of industry and government. It used to be requests for information were met with earnest efforts in providing it, or clear reasons why making the information public was not possible. Now the first response is an automatic 'No!' Filing a freedom of information request has become step one in the process of getting any information at all. What should be the exception has become the rule.

This isn't the right direction. Two thousand five hundred years of human scientific and technological advance is built on a foundation of transparency. Scientific studies must be published in sufficient detail that others can replicate the study. Background information, design of the experiment, resulting data and analytical method must all be open to inspection and critique. Learning doesn't take place any other way.

Ever wondered why new scientific discoveries, especially concerning your health, pop up constantly but never seem to go anywhere? One reason is a form of transparency absenteeism called publication bias. Experiments with positive results tend to get published and receive media attention, while those with negative results, don't. A new drug, for example, may have gone through 20 trials, but the 19 showing no effect are ignored by journals in favour of the one study showing a positive result. Thus, the impression is given that something has been discovered when the weight of evidence is just the opposite. There is a movement underway in the scientific community, deserving of

public support, demanding full transparency in drug testing, with publication of all studies regardless of outcome.

Not everyone supports open access to information though. Bureaucracies have long stood as fortresses against it. Contrary to popular belief, Galileo's heresy trial by the Inquisition in 1633 wasn't so much about claiming the world went around the sun as it was writing about it in the common language of the day, Italian. Galileo was convicted of transparency.

Bureaucracies now edit, spin, reframe, summarize, simplify, cherry-pick, fold, staple, and otherwise mutilate, information by repackaging it for public consumption. Pharmaceutical companies spend more money marketing drugs than discovering them. Government allocates more resources to selling positive stories of itself than it does improving services to citizens.

The fortress walls need to be taken down and legislation needs to be right side up. Original sources of evidence must be made available. Authors should take accountability by signing reports (as was done years ago) and not hide behind committees. Secondary and tertiary repackaging shouldn't be accepted by the public or the media without primary source material. Inexpensive means of publication and search using web-based technologies makes all this possible.

Trust in public institutions is slipping, Corporate credibility with customers and the public is diminishing. Citizen engagement in democratic processes is declining, Some real transparency would help.

Re: Special Closed Meetings - District of North Vancouver

Thank you for your letter wherein you express concerns about closed meetings of Council.

In response, the District of North Vancouver does make every effort to be transparent and accountable, which is why the majority of Council business and discussion takes place in the open forum of Regular Council Meetings, Public Council Workshops, and Public Hearings. In 2011 there were 52 public meetings and 39 closed meetings. To date in 2012 there have been 35 public meetings and 30 closed meetings. Every one of these meetings' agenda was reviewed under the terms of the Community Charter and held publicly if possible. Mayor and Council are encouraged as individuals to question the closed status of meetings and advocate public discussion wherever possible.

The purpose of closed meetings is to enable Council to discuss topics covered under the Charter for which the public may be excluded including protection of privacy, personnel matters, land matters where disclosure could harm municipal interests, law enforcement, legal matters, preliminary discussions regarding delivery of municipal services, discussions regarding preparation of the annual report, negotiations with other levels of government, investigations by the Ombudsman and review of the final audit report. In many cases the topics under discussion are at a preliminary stage and ultimately find their way into a report which is then dealt with by Council in an open meeting.

In those instances where action will be taken prior to the matter being discussed in a public meeting and Council feels that some portion of the report or decision should be released to the public for reasons of timeliness or transparency, Council by resolution authorizes the release in a specific public Council meeting. There are no set policy guidelines with respect to release of closed meetings as each circumstance is unique and as indicated above the topics which may be referred to a closed meeting are quite varied.

Guidelines for Working Groups

1.0 Introduction

In 2006, West Vancouver Council established a structure of Standing Committees and Working Groups as shown in Chart #1 (page 2). The structure provides for flexibility in tackling issues, and for engaging the community in District activities and decisions.

The Community Engagement Committee was established by Council to oversee and implement the Working Group structure.

2.0 Working Group Implementation, Role & Process

2.1 Implementation

Working Groups are implemented by the Community Engagement Committee, with mandates to address and make recommendations about priority issues. The CEC is responsible for appointing the members of Working Groups, for preparing their Terms of Reference, and for facilitating their operation.

Working groups are:

- Generally initiated in December, with a view to completing their tasks by the following year end; however, they may be started and ended at any time;
- Advisory, with broad representation from the community;
- Voluntary, serving without remuneration;
- Disbanded upon completing their tasks.

2.2 Role

The role of Working Groups is to:

- Carry out the tasks required by their Terms of Reference, within the time frames specified;
- Devise solutions and evaluate alternatives on the issues under consideration;
- Outline options and make recommendations to Council for action.

Council's intent is that Working Groups should have great freedom and flexibility to carry out their work as they see fit. Their activities could include obtaining information, evaluating alternatives, seeking expert advice, holding public forums, conducting discussions, and holding meetings.

2.3 Working Group Process

A Working Group may be proposed to Council by citizens, community organizations, elected officials, municipal departments, or, it may result from recommendations of the Official Community Plan.

Council will indicate its support for a Working Group, to be implemented by the Community Engagement Committee.

A Working Group is implemented by Resolution of the Community Engagement Committee, and will operate in accordance with the Principles and Expectations outlined in Section 4.0 (page 5).

The Working Group Process is shown in Chart #2 (page 4), and involves the following steps.

- 1. Council will indicate its support for implementing a Working Group, if it deems this to be desirable and in line with Council's priorities.
- 2. The Community Engagement Committee implements the Working Group, and works in close collaboration with District Staff to prepare Terms of Reference. The CEC's Council Members select the members of the WG.
- 3. The CEC Chair reports to Council describing the rationale, Terms of Reference and Membership of the new Working Group. Council may approve, amend, or reject any aspect of the Working Group, or defer its implementation.
- 4. The Working Group will begin its work with at least one Orientation Session where members will:
 - Review the Working Group Guidelines & rationale for the Working Group;
 - Review their Terms of Reference & prepare an initial Work Plan (Sec. 4.6);
 - Get acquainted and select a Chair & Vice Chair, preferably citizen members.
- 5. At the mid-point of its mandate, the Working Group will prepare a Progress Report to Council, and review its Terms of Reference with the Community Engagement Committee to identify modifications in WG tasks and completion date that may be indicated.
- 6. Upon completion of its assignment, the Working Group will submit a report of its findings and recommendations to Council.

Having finished its work, the Working Group will be terminated by Resolution of the Community Engagement Committee. The Mayor and Council Liaison will thank the WG members in writing, and ask them to complete a short feed-back questionnaire.





3.0 Membership of Working Groups

The members of Working Groups are appointed by the Council Members of the Community Engagement Committee. The primary criteria for selection are experience, knowledge, and expertise in the Working Group's sphere of interest, and reflection of the community's diversity.

Every Working Group shall include:

- At least one Council member;
- Five to nine citizens representing a range of interests, selected from among volunteers in the Citizen Resource Pool;
- One member of Staff;
- The Mayor as an ex-officio member.

Appointment to a Working Group is for one year, or until the group completes its work, whichever is earlier. An individual may serve for two consecutive years on any one Working Group, and on not more than two Working Groups simultaneously. Working Group membership may vary during the year, depending on tasks. Re-appointments will reflect the need for Working Group stability and membership continuity.

Every Working Group shall appoint a Chair and a Vice Chair, generally from among its citizen members, and create a work plan and a schedule of meetings.

Opportunities for appointment of citizen members to Working Groups will be advertised, so that any interested West Vancouver resident, business operator, or property owner may apply to be considered for appointment. All applications shall be kept confidential, pursuant to the *Freedom of Information and Protection of Privacy Act.*

4.0 Guiding Principles & Expectations of Working Groups

The Community Engagement Committee will support the Working Groups in carrying out their tasks and in obtaining the resources they need (e.g. expertise, information, material, process), and will monitor and evaluate their progress.

4.1 Basic Principles

The basic principles guiding the operation of Working Groups are:

- An open process, where input by citizens is welcome;
- A positive atmosphere of good faith, integrity, and mutual respect, to provide for a free flow of ideas and constructive discussion;
- Flexibility in working (meetings, discussion, compiling/evaluating information), and freedom to establish Sub-Groups or Community Forums for specific tasks within the Working Group's mandate.

4.2 Consensus and Conduct

Working Groups are expected to build toward consensus in formulating and evaluating alternatives, and in making recommendations. Unanimity is not required, nor is voting. In conducting their work, WGs shall maintain:

- A clear view of their purpose and Terms of Reference;
- A focused, task-oriented, and time-sensitive approach;
- Accountability by each member for the effectiveness of the group as a whole;
- A flexible, "wide open" process, inclusive of all interests in the community.

4.3 Communications

Good communications are essential for motivating and facilitating community participation. Accordingly, Working Groups shall maintain informative websites, whereby citizens can rapidly "tune-in" to proceedings. The websites shall include:

- The date, time, place & agenda of meetings with dates also posted on the "Community Calendar," which shall be prominent on the District's home page;
- Concise notes summarizing the key points and results of past meetings;
- Progress reports, background papers, and other appropriate material;
- A "directed" on-line forum, focused on questions and issues identified by the Working Group, and moderated by Staff Liaison, who will respond to questions posted and intervene if material is incorrect or contrary to forum guidelines.

4.4 Open Sessions

The meetings of Working Groups are open to all, which means that the public and press are free to attend. They may attend as observers, or participate through questions and "points of information", as deemed appropriate by the Chair.

The Chair will explain that:

- The role of Working Groups is to evaluate options and make recommendations on specific issues, for consideration and decision by Council;
- Working Group meetings are conducted in a spirit of good faith and respect, so as to foster a free flow of ideas and unconstrained development of options;
- The public and press shall similarly exercise good faith and respect, mindful that the proceedings are "work in progress," and not a forum for lobbying or decisions.

4.5 Closed Sessions

Working groups will not hold any closed sessions.

4.6 Records

Working Groups shall operate in a business-like manner, with the Chair and Staff Liaison collaborating to maintain concise records of activities, including:

- A work plan outlining the tasks to be done, together with timelines;
- A schedule of meetings;
- Agendas prepared in advance of meetings;

- Notes of meetings, including the key points discussed, and any conclusions or recommendations;
- · Progress reports and relevant working papers.

These records shall be posted on the group's website, with due attention to confidentiality.

4.7 Reporting

Upon completion of the Working Group's assignment, the Staff Liaison and Chair shall collaborate to prepare a report. Following review by the Working Group, the report shall be submitted to Council. The report shall include:

- An understanding and analysis of the issue under consideration;
- An overview of the work done and the process involved;
- The alternatives considered, including minority views;
- Recommendations and options for action by Council;
- Where the recommendations and options have financial implications, these should be addressed.

Working Groups are reminded that their function is advisory to Council, and that their role ends upon submission of their final report to Council. They have no continuing advocacy role concerning their findings and recommendations.

4.8 Feedback, Evaluation, and Development

It is anticipated that these guidelines for Working Groups will evolve over time, in light of actual operating experience. The Community Engagement Committee shall collaborate with Working Groups to:

- Obtain feedback regularly, as work progresses;
- Evaluate results and the WG process upon completion of the assignment;
- Make suggestions for improvement.

A Working Group shall make a presentation to Council (usually a Council Workshop), at the mid-point and upon completion of its work, or as Council may require.

5.0 Roles of Council Members, Citizen Members and Staff Liaisons

The role of the *Council Member* is to act as liaison between Council and the Working Group. This includes providing periodic status reports to Council (oral or written) and soliciting, where appropriate, Council's views on the issue being considered by the WG.

The role of *Citizen Members* is to represent the views and interests of West Vancouver citizens, and to contribute their expertise and experience to their Working Group.

The role of the *Staff Liaison* is to assist the Working Group in two ways:

Facilitation & Project Management (Staff Liaison function)

- Scheduling WG meetings, preparing agendas, and taking notes at meetings;
- Obtaining information, facilitating contact with District departments, and arranging for professional advice as required;
- Supporting the Chair and WG members in promoting effective group functioning;
- Collaborating with the Chair in preparing reports to Council.

Administrative & Clerical (Support function, directed by Staff Liaison)

- Transcribing meeting notes and maintaining the files and logs of WGs;
- Arranging WG meetings, and communicating with WG members via e-mail.
- Posting on WG websites meeting agendas, meeting notes, reference material, progress reports and any other material the WG wishes to be made public;

6.0 Rules of Procedure

6.1 Meetings

Working Group meetings:

- Are open and constructive, and are conducted in a spirit of good faith;
- May rely upon the Community Engagement Committee for support and for advice concerning questions of procedure.

Public participation:

- Public and/or press may attend Working Group meetings as observers;
- Working Groups may receive delegations and presentations, and may call for public input from time to time;
- The Chair will provide opportunity for members of the public to ask questions and offer points of information, generally at the end of meetings. There will be no lobbying or speeches.

Electronic recording of a Working Group's discussions, decisions or activities may occur with the Working Group's permission. Should anyone disrupt or impede a Working Group meeting, the Chair may expel that person from the meeting.

6.2 Conflict of Interest

Working Group members shall advise of personal conflicts of interest – for example, situations where a member:

- Has a direct or indirect interest in the deliberations, pecuniary or otherwise;
- Is involved in a matter contravening Council's conflict of interest guidelines.

Where an actual or potential conflict of interest exists, the Working Group member shall declare it and explain its nature to the group.

6.3 Authority

Working Groups do not have the authority to communicate with other levels of government, pledge the credit of the District of West Vancouver, or authorize any expenditure to be charged against the Municipality. Members shall not misrepresent themselves as having any authority beyond those delegated by the Community Engagement Committee.

Working Groups shall conduct their business in accordance with their Terms of Reference, and as directed by the Community Engagement Committee. They shall complete their tasks within the time prescribed, or such an extension as may be provided, and report their findings and recommendations to the Committee.

6.4 Budget

Each Working Group shall have reasonable use of miscellaneous services such as photocopying, paper supplies, meeting areas, appropriate refreshments, and other requirements. These are provided primarily through the staff liaison and the applicable District Division.

Funding requests for studies or public engagement processes must be reviewed by the Community Engagement Committee and referred to Council for approval.
