## VOTING DAY REGISTRATION & I.D.:

**If you are not on the List of Electors and you intend to register on Voting Day, please take note of the following:**

**RESIDENT ELECTORS** – Applicants will be required to produce two pieces of identification (at least one with a signature). Picture identification is not necessary. The identification must prove both residency and identity.

**NON-RESIDENT PROPERTY ELECTORS** – Applicants must produce two pieces of identification (at least one with a signature) to prove identity, proof that they are entitled to register in relation to the property, and, if applicable, written consent from the other property owners. A Property Tax Notice, BC Assessment Notice or Certificate of Title issued by the Land Title Office are acceptable forms of proof of ownership.

*Corporations, businesses and permanent residents of Canada (landed immigrants) who have not yet become Canadian Citizens are not permitted to vote.*

## MAIL BALLOT VOTING OPPORTUNITY:

Mail Ballot Voting is available for electors who have a physical disability, illness or injury that affects their ability to vote at another voting opportunity and for those electors who expect to be absent from the City on General Voting Day and during all advance voting opportunities. Electors will be required to sign a written certification that the above qualifications have been met. Persons meeting the above qualifications have until Saturday, November 15, 2014 at 4:00 pm to apply to receive a mail ballot. The application form is available online at [www.cnv.org/Election](http://www.cnv.org/Election). Mail Ballot packages will be provided to qualified applicants starting Monday, November 3, 2014 until Saturday, November 15, 2014 at 4:00 pm. In order to be counted for an election, a mail ballot must be received by the Chief Election Officer before 8:00 pm on November 15, 2014.

## RESIDENT ELECTORS:

**To be qualified to register, a RESIDENT ELECTOR must meet the following requirements:**

- age 18 or older on general voting day;
- a Canadian citizen;
- a resident of BC for at least 6 months immediately before the day of registration;
- a resident of the City of North Vancouver for at least 30 days immediately before the day of registration; and
- not disqualified by any enactment from voting in an election or otherwise disqualified by law.

## NON-RESIDENT ELECTORS:

To be qualified to register, a **NON-RESIDENT PROPERTY ELECTOR** must meet the following requirements:

- age 18 or older on general voting day;
- a Canadian citizen;
- a resident of BC for at least 6 months immediately before the day of registration;
- a registered owner of real property in the City of North Vancouver for at least 30 days immediately before the day of registration;
- not entitled to register as a resident elector in the City of North Vancouver;
- not disqualified by any enactment from voting in an election or otherwise disqualified by law;
- not registered as a non-resident property elector in relation to any other parcel of real property in the City of North Vancouver;
- if there is more than one registered owner of the property, only one of those individuals may, with the written consent of the majority of the owners, register as a non-resident property elector;
- the only persons who are registered owners of the real property, either as joint tenants or tenants in common, are individuals who are not holding the property in trust for a corporation or another trust; and
- not disqualified by any enactment from voting in an election or otherwise disqualified by law.
