##### 6.1 - Legal issues to think about-

**Community Charter** received Royal Assent on May 29<sup>th</sup> 2003. See <http://www.mcaws.gov.bc.ca/charter/> Contrary to the above article, there has been little to no community consultation. Unlike the extensive consultation and referenda relating to 5% of the native population of BC there has little consultation (and certainly no referendum) on legislation which impacts 95% of BC's population! The CC will be brought into force by regulation – currently by Dec 31<sup>st</sup> 2003.

Did you know that the **Criminal Code** imposes a maximum interest rate that can be charged, say for overdue payments? Yes it is a criminal offence if that annual rate exceeds 60%. See <http://www.sms.bc.ca/logo/2003/summer/summer2003-3.html>

## 2. ADOPTION OF June 19<sup>TH</sup> MINUTES

## 3. OLD BUSINESS

**3.1 CANLAN update** - Corrie questioned whether counter petition notification properly/clearly indicated liability. Use of formula did not allow even "reporters" to calculate liability, further questioning whether members of public, already mathematically challenged in a computerized world, were also so hampered.

### 3.2 Community Charter Update – Corrie

- 3rd reading given.
- Allows Council to set zero tolerance for standards, controlling business practices.
- Ability to force planting of trees on private property as well as maintaining them.
- No power to prohibit signs - only to regulate them.
- No power to prohibit types of businesses - only to regulate them.
- Transfers title of all parks in municipality to the municipality.
- Gives Council additional taxing powers on items like resort or fuel, if approved by a referendum.
- **Counter petitions** – doubled number signatures (10%) to be collected in as little time as 30 days.
- Section 293 - OCP will have more meaning. Stops Council from retroactively changing the rules on items such as zoning.

**3.3 Vending Machines in Libraries** - recommended follow up letter to Ms. Ballantyne regarding subject of no public consultation. Moved by Cathy/Eric – carried unan.

## 4. CORRESPONDENCE ISSUES

**4.1 Revised letter from FONVCA on new DNV Municipal Manager** – revised letter was sent as per the last meeting in June 2003.

**4.2 Shirtsleeve Meeting with Council: 7pm Tues Sept 9th/2003** - Agenda will be Financial Sustainability for the Long Term. Time permitting, Mountain Bike Strategy will also be discussed.

### 6.1 Legal Issues to Think About:

- Discussed legality and limitations of **Municipal Enabling and Validating** (MEVA) legislation – especially as it pertains to CANLAN

**6.2 Block Watch Parties** - a fee has been implemented which has apparently resulted in 50% fewer permits being issued. The City charges \$21 plus GST. The District charges \$50 for groups under 50 persons and \$100 for groups over 50 persons. Questioned if the fees were actually used to purchase liability insurance or was just a money grab. Suggested that Council be requested to review the item and discourage charge for block parties. Brian will draft a letter.

**6.3 Lynn Valley Library Loan** on agenda for Monday's meeting. Suggestion was made that no one should oppose it. Others disagreed and felt that this should be done only with a referendum. Clear need for more information.

**6.4 North Shore Recycling Audit** up for discussion next Wednesday. Suggested that Fred Gooch would have valuable input.
