6.1 - Legal issues to think about-

Community Charter received Royal Assent on May 29th 2003. See <http://www.mcaws.gov.bc.ca/charter/> Contrary to the above article, there has been little to no community consultation. Unlike the extensive consultation and referenda relating to 5% of the native population of BC there has little consultation (and certainly no referendum) on legislation which impacts 95% of BC's population! The CC will be brought into force by regulation – currently by Dec 31st 2003.

Did you know that the **Criminal Code** imposes a maximum interest rate that can be charged, say for overdue payments? Yes it is a criminal offence if that annual rate exceeds 60%. See <http://www.sms.bc.ca/logo/2003/summer/summer2003-3.html>
