> In the early morning hours of Sunday Sept 16 - 01, I was
> attempting to leave my residence only to find that the entrance to the
> road was blocked by a vehicle. The vehicle was parked on a District road
> (cul-de-sac). I went back to my residence to phone Tel 604-985 -1311 with
> a request to get in touch with District Bylaws for the purpose of removing
> this vehicle. The time was 9.09 am. As there was no answer from District
> Bylaws I phoned the RCMP receptionist with a request for action by
> District Bylaws and/or the RCMP.
> Following this I went back to my parking lot only to find that the
> vehicle blocking the road had left in the meantime.
> There were other vehicles parked in the cul-de-sac making it
> difficult to exit but I managed to get around them and I subsequently left
> my complex to go about District business.
> Upon my return home late in the afternoon, I was told that a
> District Bylaw officer had visited the area several times after my
> departure and had handed out parking tickets explaining to the complaining
> parking violators that he was obliged to write tickets since Councillor
> Crist had made the request.
> As a result, I have received at least one phone call from a violator
> threatening legal action against me for mischief since the officer told
> him he was writing tickets upon the request of Councillor Crist. Many more
> people have complained to me since. It turned out that there had been a
> garage sale in the neighborhood and people were parking in places they
> were not supposed to.
> While I do not fault the Bylaw officer Mr. Reed for going about his
> business, I must protest in the strongest possible terms against the
> totally unprofessional manner in which this was done.
> To mention the name of a complainant is not acceptable. To tell the
> recipients of the parking violation tickets, that it was a District
> Councillor by the name of Ernie Crist who complained, is contrary to even
> the most rudimentary professional conduct. You will recall that a similar
> incident occurred a few years ago which could have led to charges of
> mischief against the District.
> The conduct of District Bylaw officers while carrying out their
> duty is, in the final analysis, your responsibility and it would appear

> forward to your early reply.
