Dear Sue Mitchell:

Thank you for forwarding me the report prepared for District Council dated March 7, 2001 "Federal/Provincial Infrastructure Program Opportunities" which would indicate that the District submitted an application before the March 15, 2001 deadline.

I note that it was presented to Council on March 12, 2001 (Item 10) and that it was approved & unanimously carried that an application be submitted based on the projects outlined in Appendix A of the report. Considering the wide ranging scope of the various projects (14 Green Projects & 8 Community Infrastructure Projects), I share the District's disappointment that we were awarded absolutely nothing by the federal/provincial government's initiative.

As you are aware, my initial inquiry was directed to Mr. Howie who has not responded. Of the 3 questions I asked, your response leaves only one unanswered, namely: why did we not receive any funding? I would appreciate if you or Messrs. Howie or Zerr can provide any information in this regard.

Be that as it may, I would like to ask the review board directly why not one of the District's 22 projects were approved for funding. Therefore please supply me with the necessary contact information so that I may properly direct my inquiry. I will also bring this to the attention of both my provincial & federal members of government.

At the same time, I believe it would be worthwhile for the District to obtain copies of the successful applications submitted by the City of North Vancouver & Lions Bay. Examination of their winning proposals might give an indication as to why theirs succeeded while ours did not. Perhaps this will give us a better steed for next time.
