I would like to note for the record that Mayor Bell phoned me yesterday to respond to my e-mail regarding the volunteer reception being held at the Canyon House Banquet Room at the Capilano Suspension Bridge. He informed me that those who arranged the event were not involved or aware about any redevelopment applications being processed by the Planning Department. In other words, the venue of choice is simply a coincidence. The District is renting the Canyon House at full cost and the parking is not being waved. A number of other venues were considered, including Grouse Mtn., Northlands, and the Plaza. Mayor Bell noted that both West Van & the City host sit-down dinners for their volunteers at a restaurant, so the District wanted to do something similar although not host a dinner. The increased cost is apparently very little -- the rental of the room -- because most of the cost is for catering and the beer and wine. I fully accept Mayor Bell's explanation and retract any suggestion that the location of the volunteer reception was perhaps linked to a redevelopment application by the Suspension Bridge. Having said that, I have attended previous volunteer receptions held at the District Hall and found them to be very pleasant evenings and never once thought they should be held elsewhere.
