Dear Clr. Crist

I sympathize with the sincere concern expressed by your motion, however I do not support it. You are right, war and peace, and our role in the world community should be the concern of every Canadian. However it is my opinion that the municipal context is not the appropriate forum for this important debate.

As Ms. James has pointed out, the subject of your motion is outside the authority of municipal government. I agree and would add: it is outside this Council's mandate as well. Foreign affairs and world peace issues were not a part of the municipal campaign. Therefore the citizens who elected this Council have not conferred a mandate to act on such matters on their behalf. Unless there is an attempt by Council to engage residents in discussion in a significant way, this motion presumes rather than expresses public support and cannot represent a collective opinion of the citizens of the District of North Vancouver.

Dear Ms James;

The Prime Minister of Canada and his government at this very moment are clearly in need of moral support from all Canadians on this question and support from municipalities representing as they do the grass roots of Canada is completely appropriate.

War or Peace is not a question to be debated by any single political jurisdiction but is the concern and responsibility of all Canadians and all democratic jurisdictions. Municipalities have not only the moral right to speak up on such a life and death issue but they have the duty to do so.

The reasons you put forward in your argument against my motion are similar to those put forward during the Cold War when some people objected to a resolution declaring the District of North Vancouver a nuclear free zone. The counter argument was that if anybody can guarantee that the radioactive dust clouds would stop at the District border than the argument that this is not a municipal concern is valid, otherwise it is not. What I am proposing in my resolution is already occurring on a large scale throughout the world including in the US where countless cities have spoken up against this proposed war unless it is sanctioned by the UN .

Dear Clr. Crist:

Apologies, but my opinion remains the same. In fact, I think that for the most part, experience will show that economies for those countries on the winning side receive a boost from a war, rather than the opposite.

With respect to federal contributions to the costs of infrastructure, education and health there is no doubt that these should be increased; in fact, with respect to health, the feds should ante up according to the agreement with the provinces, viz. closer to 50-cents of every dollar.

That said, as is usual with government at all levels in this country, I believe you will agree that, properly spent, there is more than enough money to go around to cover all of our necessities and still have dollars left over to pay off some of the national debt. But, instead, the people allow governments to spend on unaccountable HRDC scams, on Bombardier SkyTrains instead of on more economical transit solutions that would achieve our stated goals; on gold-plated FastCats instead of ferries appropriate to the runs; on gold-plated e-Comm systems that leave citizens unprotected and on gold-plated severance packages to departing bureaucrats who lack any vestige of conscience.

So, rather than this type of motion, I would prefer Council to concentrate on fulfilling its chief mandate - parks and recreation, water, sewers, zoning and by-law regulations, garbage collection etc. If/when it has done that job with efficiency, fiscal prudence and accountability then it can start looking beyond its boundaries. To this point, I don't see/hear District citizens clamouring to have Council speak to the Federal Government about wars....they want to see our own messes cleaned up first.

Lastly, if members of Council, or individuals and groups within the community feel
