As you know by now, the Council of the District of North Vancouver refused the offer to purchase the valuable property at 2708 Panorama Drive. The offer to the District was at the owners original purchasing price.

As you pointed out in your e-mail, the acquisition of this property, would be an important step in realizing the long term objectives outlined in the recommendations of the District Waterfront Task Force. These recommendations were produced by the most civic conscious elements in the District. They expressed a progressive vision for the District's Waterfront, including its control by the public, including the elimination of the ugly structures along the foreshore.

While I am not at liberty to attach names to the rationales expressed by individual Council members, I can tell you that most of the opinions expressed were nothing more then regurgitated excuses of the erstwhile anti social CCA. It has once again become clear that the CCA mentality is still very much in control of District affairs. In one sense you can count yourself fortunate that you were spared the pain of having to listen to the elected CCA mouthpieces holding forth.

You may be aware that I indicated that I may not run in the next civic election. However, the reactionary posture of this Council may well force me to rethink my stance. I would urge you to prepare yourself and your supporters for the next election.
