A MESSAGE FROM ERNIE CRIST

* At the Council meeting of Sept. 2 Mrs Maureen Bragg, Chair of the Lynn Valley Community Association, addressed Council. She charged that the recent publicity in the local press concerning the Lynn Valley Community Plan, the proposed Library and Civic Square project contained erroneous information. No specific name of the author of the alleged erroneous information, story or letter to the editor, as the case may be, was mentioned.

Neither did she make any specific mention as to what part of the story or letter was inaccurate. However, it was I who recently wrote a letter to the NEWS in which I made some serious charges as to how the District mishandled the Lynn Valley Community Plan, of which the proposed Civic Square including the Library is merely a part. I also pointed to the lack of leadership in realizing any potential financial benefits accruing to the municipality as a result of the densification of the Lynn Valley Core area which has already taken place.

I was also highly critical of the proposal to ask the residents of the District for another 18 Million Dollars for the Library and the commercial sector of the civic square, when funds surpassing this amount are already in place while, at the same time, the District uses millions of dollars from its Heritage Fund to cover operating expenses. In any case, I stand by my letter to the NEWS and I challenge anybody to point out any information at variance with the facts. This is provided that the criticism by Mrs Bragg was indeed directed at me.

As I have stated on numerous occasions, I am in full support of a new Library. But I will not support asking the District residents for another \$ 18 million when an amount equal to that figure and more is already available to the District. This includes \$ 6 million from the old referendum for the Library, close to \$ 8 million already allocated from the Heritage Fund, close to \$ 4 million expected from the sale of the existing Library site and \$ 2 million from the Federal Government. Neither will I support asking the public for additional money as long as the District misuses its Heritage Fund.

As to the area within the Lynn Valley Core already developed to a higher density and sold, to the residents as "Pedestrian Oriented" complete with tree lined boulevards and designated bicycle lanes, I can only reiterate that it was a hoax from beginning to end.

The redevelopment of the Lynn Valley Core area, is anything but "Pedestrian Oriented". The developers got what they wanted and moved on. The District residents got nothing except the bill for the infrastructure for the redevelopment which has already taken place.

Maybe some people don't know the difference between a "Pedestrian Oriented Town Center" and a Car Mall but I do - maybe they don't know the difference between a small Civic Square containing a Library and the larger Lynn Valley "Pedestrian Oriented Town Center" but I do - maybe they are unaware of the opportunities which were available to the District to share the profits with the property owners as a result of large scale densification, but I am.

I would like to suggest that the people who claim that my letter to the NEWS was not valid, read it again and this time more carefully, if indeed this is what was being referred to. As I pointed out in my letter in the NEWS, as long as the residents of the District are silent in the face of mismanagement or even defend it for whatever reason, it will surely continue.

The Lynn Valley "Pedestrian Oriented Town Center" is and has been nothing less than a scandalous hoax by any standard - yet another example of the District's incompetence, notwithstanding that some people worked hard in helping to draw up the Plan and did so in good faith.
