> I congratulate you on your interest in the upcoming Pari Zangeneh Concert and the
possibility of the three North Shore Councils agreeing to offset the Centennial Theatre
rental fees as a way of showing support for the relief efforts for victims of the
earthquake in Iran.
> I am disappointed however, that the main thrust of your response to my memo yesterday
to Council asking if they would support such a proposal, seems to focus more on your
desire to be recognized "first" as responding to an e-mail we both received over the
weekend. This is not a matter of who was "first", Councillor Crist, but that the
appropriate information about the situation be gathered "first", and then possible
options be presented to Council for their consideration. It appears we both came to the
conclusion that reducing or eliminating the theatre rental fee would be one possible and
appropriate way of showing support for the relief effort. The difference between our
respective follow-up, Councillor Crist, is that as Mayor and CEO, I attempted to gather

the required background information to make a decision, contacted the other two Mayors to determine their interest, contacted the representative from the Iranian Canadian Cultural Association and then sent out an e-mail to District Council members to solicit their opinion. I did further follow-up today and determined that the Centennial Theatre rental fee for this event is a basic \$1,947 plus \$1 per person attending renovation surcharge. If the concert sells out at 700 attendees, the total cost for the rental would be

Vancouver be invited to do likewise, with the result that, if agreed by both Councils,
100 % of the total fees charged by the Centennial Theater for this fund raising event
would be covered by donations from the three North Shore Municipalities.
       Rationale:

       According to Press Reports the recent earthquake in Bam, Iran has literally
leveled a city with up to 40,000 estimated casualties.
        The large Iranian Community on the North Shore will organize a benefit concert
at the Centennial Theater to raise funds for the victims of the Bam Earthquake.
        While Municipalities may not make direct cash donations for such purposes, they
may, however, forego charging fees for an event taking place at facilities within their
jurisdiction that is, strictly speaking, a fund raising event. Since the Centennial
Theater comes under the jurisdiction of the North Shore Recreation Commission, the money
to cover the fees would have to be given to the Recreation Commission or the Centennial
Theater directly.
       An alternative would be for both the City and the District of North Vancouver to
request the Recreation Commission to forego charging fees for this event. The Recreation
Commission comes under the jurisdiction of both the City and the District of North
Vancouver. However, this scenario would leave out West Vancouver, since West Vancouver is
not in any way connected with the Centennial Theater and/or the North Vancouver
Recreation Commission.
       However, since there is also a sizable Iranian Community in West Vancouver, the
Council of West Vancouver may wish to also make a donation to cover the fees for this
event. In lieu of this, the best solution may be to make a direct cash contribution from
Council Reserve to the North Van Rec Commission to offset the cost for fees and ask West
Vancouver to donate one third of such cost.>
