> I recently submitted a motion on District Council regarding free annual passes which the North Vancouver Recreation Commission extends to elected officials who serve on the Commission as appointed members of Council. The point of my motion was to seek a legal opinion as to whether members of Council, who have accepted such free passes for themselves and/or members of their families, are in a conflict of interest situation and should subsequently excuse themselves when Recreation Commission matters come before Council and/or whether they should forfeit the offer to receive free passes from the Commission.

> The conflict of interest guidelines clearly state that no member of Council may accept any gift from any organization, corporation or individual but if they do, they must declare their conflict and excuse themselves when an item pertaining to such an organization or individual comes before Council. In the course of this debate, I informed Council that when I first got elected more then twenty years ago and when I served on the Commission I had myself accepted such a free pass.
