Congratulations Councilor Nixon for getting such a quick response from the Clerk's Department in obtaining a transcript, incomplete as it is. You must have pull.

I do indeed NOT wish to carry on with this issue either - I know what happened. But for the record, the section from the transcript you are quoting from is taken out of context and takes on an interpretation that is in conflict with the purpose of the question and the spirit in which my question was put.

Councillor Crist:

While reluctant to respond to your message for fear of atttaching any credence to your remarks I will not tolerate, in silence, your

berating of me and my handling of the July 8th meeting.
