Leadership's great, but having enough time for all that needs doing is another matter.

The point I was trying to make is that one only has so much time and energy to devote. That applies, also, to Council. If you are willing to concede me that point, is it not appropriate for me to also suggest that Council's immediate and primary responsibility is to deal efficiently with the tasks that come within its official mandate under the LGA?

As things stand, Council rarely completes its agenda in a timely fashion, if at all, so let's deal with first things first. Rather than adding items which are not strictly within its mandate, it's my opinion that Council needs to look for ways it could cut back on the number of issues that are brought to the table.

Another aspect to the discussion is that of community responsibility. If we are not to be handing over our whole pay cheque to taxes, citizens must stop looking to government to be 'all things to all people,' and take up some of these cudgels for themselves. If they have not the will or the initiative to do so then, as far as I'm concerned, they abdicate the right to expect it of government - i.e. other taxpayers.

So, again, let's make sure we get things running more smoothly and efficiently at District Hall, before we look further afield for more work to load on Council and Staff.

Dear Clr. Crist:

The idea of a community discussion on domestic violence - and/or of gratuitous violence on TV and in video games - is a worthy one. Individual members of council could either attend, or involve themselves in the actual organization of a symposium as they wish.

That said, I believe this to be a cause which is better taken up by the community itself. If/when the community drafts a report and recommendations, it would be more appropriate for a representative group to present its findings to a level of government that has a mandate which enables it to take action.

Local government is certainly affected to the extent that violence in the community costs us all - emotionally and fiscally. However, Council has no control over TV programming, so it is not in a position to take any stronger action than to write a letter of support for more control over programme content.

For this reason, I believe it would be preferable for Council to explain that in a supportive letter to NSTVN, rather than to raise false hopes by including the matter on Council's already too full agenda, or by taking responsibility for a symposium.

I would be very interested to read other comments to see if I am totally out of step on this one...
