> Delegations are scheduled in accordance with the "Public Input at Regular Council
Meetings" policy. Delegations usually fall into one of two categories. The first
category is for information presentations to Council - a presentation from the GVRD or
Translink would be a typical example of this type of delegation. The second category is
to bring forward a new issue for consideration by Council.
> If an item is already listed on an agenda for consideration, a delegation is not
normally scheduled. Instead, Council's policy provides members of the public with an
opportunity to speak to the item on the agenda for two minutes, either during the 30
minute Public Input period or immediately before the item is considered. From time to
time, speakers have asked to have their speaking time extended by a minute or so -
Council has usually granted these requests, time permitting.
> You are correct in noting that the Deep Cove Yacht Club was given an opportunity for a
delegation recently in spite of the fact that the item was already listed on the agenda.
This was a departure from our usual practice. In this particular case, staff
specifically requested that the Yacht Club be provided with an opportunity to present a
brief history of the Club. An opportunity was also provided for a delegation
representing the opposing viewpoint.
> Ms Roberts was advised of the Public Input policy and encouraged to take advantage of
the two minute speaking opportunity this evening.
> I trust this clarifies the policy.
