He requested a 90-day suspension of the Court ordered sale of said Ferry in order for the Society to undertake a shipyard lift-out and professional examination of the vessel and for the City to approve an expenditure of \$19,500. towards said examination.

**“THAT** Council, notwithstanding the City of North Vancouver’s current Seven Seas vessel disposal process, express an interest in exploring the opportunities inherent in possible preservation and restoration of the former North Vancouver Ferry No. 5 and its retention as a viable heritage feature at the Foot of Lonsdale Avenue;
