Dear Mayor and council,

I just can not let this situation happen.

I truly believe that future councils will regret the short sighted decision of this council to not install proper bike lanes on Lillooet Road. This road is an access road to, by far the largest, cycling destination on the north shore. Thousands of cyclist drive their cars from Vancouver and Burnaby every year to cycle in the LSCR. This road also services the north campus of Capilano College. If we can do something that might encourage even 10 percent of them to leave their cars at home, think of the huge reduction of air pollution on the north shore.

Communities all over the world are struggling with ways to encourage more people to cycle. In a lot of cases, there is no room and a 4.3 lane is the only acceptable choice. This is one of the few routes in North Vancouver that actually has the room to add proper bike lanes. To not do it when the GVRD is willing to pay is unthinkable!

I know council thinks I am being selfish, but I am not thinking about myself. I already live on Purcell. I am thinking of all the cyclists that choose to ride from Vancouver, Burnaby and lower parts of North Vancouver. I have also asked a cycling advocate group for their opinion. Members from the VACC (Vancouver Area Cycling Coalition) have agreed to ride up Lillooet Road and give me their opinion. They will notify me after their ride. The VACC have been very active in other areas of the GVRD.

The City Of Vancouver is currently planning dedicated bike lanes on Hornby and Burrard Street. They have already installed bike lanes on Pacific Boulevard. The North Shore Master Bike Plan has been in effect for eight years. Since then, the City Of North Vancouver has built bike lanes on Low Level Road and also on Queensbury. Building bike lanes on Lillooet Road is a rare opportunity for the District Of North Vancouver to show a commitment to alternate forms of transportation.
