Dear Mr. Willett:

There are large areas adjacent to existing residential areas which are administered by the GVRD including electoral area A and the provincial Government. My personal view is that we should look at creating a large outdoor (international) recreational playground as could possibly be done with electoral Area A which the GVRD offered to the District free of charge but which the District turned down years ago.

This was done because politicians as a rule cannot see beyond the end of their noses. They simply do not have any vision and as a result they not only get themselves into trouble all the time but everybody else as well. It was agreed by District Council two years ago that all options would be explored and a strategic plan readied for Council's consideration. This has not been done. Indeed I doubt very much whether even a serious start has been made. The point is that we need a long term solution for the simple reason that this sport will continue to grow dramatically.

Once again as a result of poor leadership this has not happened and the whole issue is in limbo. This is neither fair to the residents neither is it fair to the Mountain Bikers. If you ask a question on the status you get either bafflegab or lies or silence or the proverbial runaround. But if you call anybody on it you will be in violation of the harmonious workplace policy.

The main thrust of my motion is to force the hand of Council and come to grips with this issue instead of letting it slide to the point where we are going to have a major backlash. If I would not care as you claim I would not bother with any of this. I don't need the aggravation. I would just let it go and ignore people complaining about as yet another example of the stupidity of governments. There is no substitute for leadership. Bureaucratic bafflegab and political ad hoc solutions are not solutions, they merely add to the problem later on.

As for the growth of this sport, I am only quoting people who claim to be experts from both sides of the issue including the Mountain Bikers themselves albeit in a different context.
