Dear Councillor Crist,

I generally agree with the thrust of your motion. Similar to the Canadian health care system, our local NV Rec. Commission appears to be a bottomless pit that no amount of money can ever fill. Last year alone, for example, the Griffin Rec. Centre recorded nearly 700,000 customer visits to the facility. When you consider such a huge number of visits and the revenue that must be generated annually (assuming the vast majority of these visits were paid for by either registration in a specific program or a general membership fee) it is hard to believe that the facility cannot be entirely self-sustaining with more than enough money for maintenance, capital renewals, and even possible future expansion. Indeed, the municipality owns the building and the land it sits on so there is no rent or property taxes to pay. Perhaps not every other Rec. Centre is as successful in the number of visits as Griffin is; however, common sense dictates there must be an enormous amount of bureaucratic waste at the Rec. Commission for the District having to dump an additional \$6 million into the system every year, and yet the Commission still has insufficient funding for its needs. It is unfortunate that any discussion about reorganizing the Rec. Commission becomes politically polarized. For some, the Rec. Commission is a "sacred cow" that must be continually funded, but never questioned. Hopefully your motion will receive support.
