Thank you for your consideration, Susan. When planning for Fromme mountain please put yourself in the residents' shoes. Would you want this element in your backyard? It is one of the few places to live in DNV that is still a peacable one, and many of us have lived here for over 15 years. On November 18th, we hope you have planned for the Residents Only Parking to remain in effect in our neighbourhood, as it has been **successful** as an experiment, controlling mountain biking and commercial dog walking in Mountain View Park. I do not wish to have to go around and collect another petition, <u>as it is clear this experiment has worked</u>, and should remain in effect as long as mountain biking is accessible in Mountain View Park, and other access points in the RPO designated area.

People do not feel safe against the intimidating bikers, and the NSMB.com board tells it all with its attempts to discredit me, and spread outright lies to others in order to "shut me down" and make me worry about my safety, and the safety of those who live in my neighbourhood (who may or may not show up on the 18th with the biker presence there). Many of these folks are oldtimers who have lived here for 30 and 40 years.

<u>Please include the RPO in your plans</u>, as it is clear that Fromme is going to go to the bikers, and all we ask for is a peacable neighbourhood, like we have had over the past year or so. Thank you, Susan. (We just need small signage near Mountain View Park and other strategic areas, reminding folk about the RPO area, as many see no signs and get ticketed, and then complain about lack of signage in the area. That is the only real problem we have had with the RPO). Take care, and see you on the 18th.
