Or the homeowners > may 'do-it-themselves' and end up causing more damage to our > environment through lack of knowledge about the products (excessive > application) or improper use of the products or equipment (spillage). > What do the District groundskeepers use to control weeds in public > lawn spaces? If what they use keeps the weeds in check, then let > everyone know what it is and promote it. If they don't use anything > effective, and there are weeds in our public lawn spaces, consider if > you want your lawn to look like that. > Please consider all of the ramifications of passing this bylaw. And if > you do pass it as is, please change the word 'Control' to > 'Prevention'.
