Ms Hilsen:

As you are aware Councillor McKeon-Holmes recently requested that the District compensate her for being Acting Mayor over and above the compensation she is entitled to by policy.

You are undoubtedly also aware that contrary to policy, this item was originally dealt with in Camera and when I insisted that it be dealt with in public, Councillor McKeon-Holmes ostensibly withdrew her request. However, it appears there is no official record indicating as to whether Councillor McKeon-Holmes did or did not receive the amount she had requested from the municipality.

Please advise as to what the final status of this matter is and what the official documents to this effect indicate. You may recall that Councillor McKeon-Holmes on a previous occasion had accused Councillor Crist of having claimed compensation from the municipality (Gas mileage) in violation of existing policy (Theft from the municipality?) and did so in public.

You may also recall that a subsequent investigation determined that these accusations against Councillor Crist were false and constituted slander on the part of McKeon-Holmes. You may also recall that there was indeed a discrepancy in compensation of car allowance entitlement on the part of two members of Council including Mayor Don Bell who had "forgotten" to enter the mileage in the report and subsequently had to reimburse the municipality. I am looking forward to your response.
