All the things you mention in your wish list for Lynn Valley were proposed and could have been obtained as part of the implementation of the Lynn Valley Community Plan, including a truly Pedestrian Oriented Town Center as promised, including designated bicycle lanes, improved recreation and arts facilities, even a community and senior center along with the Library, as well as enhanced arts and recreation facilities and a larger swimming pool.

What is more, it could have been obtained virtually without cost to the District. This was possible as part of a comprehensive municipal private partnership and redevelopment plan of the Lynn Valley Core as outlined in several motions made to that effect. As a (nearly) lifelong resident of Lynn Valley, I am writing to you in support of the most positive retail venture to have occurred in our area in years.

I know you must by now be familiar with the Sugar Suite coffee shop in terms of petitions, complaints, and paperwork. Regrettably, you have probably not had the chance to appreciate it for what it is offering the surrounding neighbourhood.

In less than one year, the Sugar Suite has become somewhat of a hub for social, musical and community-based initiatives.
