NOTICE OF MOTION - Submitted by Councillor Crist

Whereas BC Hydro has spawned a new corporation called BCTC which is also responsible for the cutting of trees on or near Hydro power lines including on private property and

Whereas BCTC recently cut trees in or near residential areas in the District apparently without adequate consultation with the municipality and or the affected private property owners and

Whereas this appears to be a departure from previous existing policies of consultation and cooperation between residents, the District of North Vancouver and BC Hydro and

Whereas this has caused a considerable concern and a predictable backlash from the affected public and

Whereas District Council recently adopted a motion in principle that a new tree protection and tree replacement policy be initiated which in essence determines that henceforth no tree in the District may be cut unless it is replaced in the immediate vicinity and

Whereas this motion has been referred to staff for a report and

Whereas implementation of such a policy if adhered to by BCTC would in the main meet the main objectives of the District and the affected residents since trees having to be removed by BCTC ostensibly for safety reasons would be replaced by an equal number of suitable trees

Therefore be it resolved that Council request staff to expedite this report based on this motion and return it to Council for a decision as soon as possible and further be it resolved

that Council immediately inform BCTC of this intended District green protection and tree replacement policy and request of BCTC to henceforth abide and dovetail its own policy with that of the District and subsequently at its expense replace any tree it needs to remove and that this be done in consultation with District staff and the affected property owners.
