Subject: Two Arrested at Scene of Bank Robbery

Yesterday just before noon, a male and a female were arrested outside of the North Shore Credit Union located at 3730 Mount Seymour Pkwy after a confirmed robbery had just taken place. A female and a male were observed to approach the bank and as the male waited outside the front doors, the female continued to go into the Credit Union. The female passed a note to an available teller indicating that it was a robbery. The female left the bank with a small amount of cash. The robbery was caught on the bank's video surveillance system. North Vancouver RCMP along with Burnaby RCMP task force members arrested the two after they had left the bank.

Lance Perrier, a 39 year old of no fixed address, along with the female who cannot be named as she is under the age of 18 were held in custody last night. Both will appear in court this morning in North Vancouver to face robbery charges. Both of the accused are known to police.

The Burnaby RCMP task force had been conducting surveillance on the two accused for unrelated matters when the bank robbery alarm was received by the North Vancouver RCMP dispatch leading to the swift arrest of the two in concert with North Vancouver members. All money taken during the robbery has been recovered.
