If you were to pay a Councillor in the District a hundred thousand dollars a year you might still only get more of the same. This is because notwithstanding the salary issue, the public does not consider local politics as being important. Unfortunately the public have a point. What I have said on more than one occasion is true, we Councillors pretend to be important and the public pretend to pay us.

Thank you for the opportunity to address this subject.

When one considers that when we elect a Mayor and Council we are actually hiring seven people to oversee a \$ 115 to 120 million dollar annual operation. This is not really a part time job. We are looking for LEADERSHIP.

In order to attract experienced, talented, qualified and competent people like any other corporation you have to compensate them accordingly. In so doing I would like to recommend for the committee's consideration the following annual package.

Mayor: Salary. \$ 80,000.00

\$ 25,000.00 tax exempt for

expenses.

\$ 5,,000.00 RRSP annually in

lieu of a pension.

Councillors:

Salary. \$ 40,000.00

\$ 12,500.00 tax exempt for

expenses.

\$ 5,000.00 RRSP annually in

lieu of a pension.
