Hi Cathy,

This is really interesting - just the kind of thing I like to get my teeth into. Let's start with some points:

- a) There are no explicit requirements to keep the information confidential in fact the media regularly publishes much of the information and I don't believe they have any special priviledges.
- b) Much of the information kept by government (including municipal which is really provincila have time limits as to how long the records must be retained but and here is the point they don't necessarily have limits to being copied unless it EXPLICITLY does not allow that. In Canada the default is that all public records are available to the public.

In conclusion - since there appears to be no statement explicitly saying these records may not be copied (in fact I believe there is a section which requires that all members of council be given a copy) they can be - and copies should be made freely available to the public. The Community Charter did bring about some changes - which may not be fully understood by all.

Since I am currently in Ottawa I will have more on this later.

Hi Agnes
Thank you for your response.

The Community Charter deals with the issue of copies being available. I refer to Section 95 (3), which states that a person may have a copy of any municipal record which is available for public inspection. Section 194 (3) says that fees may not be imposed for items in relation to Parts 3 or 4 of the Local Government Act, the portions of the LGA dealing with elections.

Would you please take a look at these sections specifically? As I have done in the past, I could come in and try to make notes from the records. A concern when doing that is the possibility of transcription errors, so copies would always be preferable.
